Course Overview

This is an elective honors-level advanced research program that is formulated to reflect the skills, behaviors, techniques, and proficiencies necessary for conducting authentic science research. Students will learn how to analyze and interpret experimental data generated in class and by other researchers. The ultimate goal is for students to continue their research engagement by participating in the Rutgers University / Waksman Student Scholars Program during subsequent years at East Brunswick High School or similar molecular biology research opportunities at their post secondary school of choice. Students will receive honors credit. Laboratory experiences are embedded in the curriculum and will take place during the regularly scheduled class periods.

This is course for students in grades 10-12. Students must obtain a grade of A- or better in Academic Biology or a B- or better in Honors Biology in order to enroll.

Modifications

Each teacher, each student, each classroom is unique and adaptations are specific to each situation. Differentiating instruction and providing multiple ways to assess allows more flexibility for students to meet the standards and requirements of the class. Below are samples of the types of adaptations/modifications that may occur for students based on need including ELLs, students with a 504 Plan, Special Education, Basic Skills and Gifted and Talented students.

Materials and Resources

This is a laboratory based course that uses seminal primary research articles in the field of molecular biology as the text.
