Enduring Understanding

The four types of nail implements/tools are: equipment, implements, materials, and professional cosmetic nail products. Reuseable implements are used on more than one client because they are properly cleaned and disinfected. Disposable implements cannot be reused and must be thrown away after a single use. The cosmetologist and the client should wash their hands before a nail service is to reduce the likelihood of spreading communicable diseases in the salon. A consultation should be performed each time clients have a service. Basic nail shapes for women are: round, oval, square, squoval, and pointed. The most popular shape for men is round. Effluerage is most appropriate massage for hand and arm massage because it is gentle. Basic if focused on the nails where spa is on the nails and skin. Aromatherapy oils are used in the manicures and massage to induce relaxation.
