Enduring Understanding

Discloses all medications, both topical and oral, along with any skin disorders or allergies that might affect treatment. Clients should not have waxing done if using Accutane in the last six months, taking blood thinner, taking drugs for autoimmune diseases, including lupus. Two types of hair removal is permanent and temporary. Electrolysis is the removal of hair by means of an electric current that destroys the growth cells of the hair. Photoepilation uses intense light to destroy the growth cells of the hair follicles. Laser hair removal, a laser beam is pulsed on the skin, impairing hair growth. Permanent hair removal should not be performed in the salon without special training. Depilatory is a substance, usually caustic alkali preparation, used for temporary removal of superfluous hair. An epilator removes the hair from the bottom of the follicle. Wax is a common epilator.

Know the types of hair removal. List the safety precautions.

Cosmetologists should have a thorough understanding of hair removal because: Removing unwanted hair is a primary concern for many clients, and being able to advise them on the various types of hair removal will enhance your ability to satisfy your clients. Learning the proper hair removal techniques and performing them safely makes you an even more important part of a client's beauty regimen.
