Harry Potter and Literary Criticism: Hogwarts Years 5-7+

Credits: 2.5 Grades: 10, 11, 12

In the elective Harry Potter and Literary Criticism, students will read Harry Potter and the Order of the Phoenix, Half-Blood Prince, and Deathly Hallows, watch the films and analyze Rowling's writing through several critical lenses, including feminist, Marxist, Freudian, and others. The overarching theme of the course will focus on Harry Potter's increasing acceptance of his role as a hero. Class time will be spent reading the novels as well as secondary sources, watching the films, and applying various theories of literary criticism to the novels during discussions, as well as on written responses. There will also be a strong creative component to the class work, in modes including, but not limited to narrative response, drama, video, drawing or model building.
