

# Unit 6: Research-Based Expository Writing "Feature Articles"

Content Area: **Language Arts Literacy**  
Course(s): **English 10 CP, English 10 Honors**  
Time Period: **Marking Period 3**  
Length: **10 Blocks**  
Status: **Published**

## Course Description

---

The English 10 CP course is a survey of American Literature from pre-colonial to present day that includes textbook, novel, essay, and online resources that can be utilized via the Google Classroom and other applications. Students will embrace the approach of Workshop while working through the course curriculum. Teachers will present mentor texts to model/enrich alongside student selections of works that coincide with each unit of study.

## Unit Description

---

### Stage 1-- Desired Results

**Unit Purpose:** The purpose of Unit 4: Research-Based Expository Writing *Feature Articles* is for students to complete the research process to create a feature article. Feature articles are research-based timeless human interest stories. Students will engage in the writing process by gathering ideas from various informational sources, reading mentor critical reviews, collecting and implementing craft moves from professional authors, writing independently, and revising both independently and with peers. Students will self-select topics. Throughout the unit, students will demonstrate application of standards through individual conferences and drafting. By the end of the unit, students will demonstrate application of the standards through a final feature article.
