Transfer Skills

Students will explain how the integumentary structures protect and help to regulate the body, and describe how the skin and its components make up a complex organ that protects and interacts with other body systems.

Enduring Understandings

- The integumentary system is the body's first layer of protection of underlying tissue and organs from impacts, chemicals, and infection.
- The integumentary system is instrumental in maintaining homeostasis within the human body which includes the prevention of fluid loss, temperature maintenance, synthesis and storage of nutrients, and regulating secretions and excretions.
- The integumentary system provides important sensory receptors which provide information to the nervous system.

Essential Questions

1. What are the main structural features of skin and what are their functional significances?
2. What factors contribute to skin color and how are they affected by UV radiation?
3. How does the integumentary system help maintain homeostasis?
4. How does skin respond to injury and repair itself?

Learning Objectives

Students will be able to:

- List the general functions of each membrane type, cutaneous, mucous, serous, and synovial
- State the locations in the body of each membrane type
- List several important functions of the integumentary system
- Explain how the functions of the skin are accomplished
- Recognize/identify the following skin structures: epidermis, dermis(papillary & reticular layers), hair and hair follicles, sebaceous glands, sweat glands
- Name the layers of the epidermis and the characteristics of each
- Name the factors that determine skin color

- Describe the function of melanin
- Differentiate between first, second and third degree burns
- Describe the characteristics of basal cell carcinoma, squamous cell carcinoma, and malignant melanoma
- List several examples of integumentary system aging

Disciplinary Core Ideas

LS1.A: Structure and Function

- Systems of specialized cells within organisms help them perform the essential functions of life. (HS-LS1-1)
- All cells contain genetic information in the form of DNA molecules. Genes are regions in the DNA that contain the instructions that code for the formation of proteins, which carry out most of the work of cells. (HSL1-1) (Note: This Disciplinary Core Idea is also addressed by HS-LS3- 1.)
- Multicellular organisms have a hierarchical structural organization, in which any one system is made up of numerous parts and is itself a component of the next level. (HS-LS1- 2)
- Feedback mechanisms maintain a living system's internal conditions within certain limits and mediate behaviors, allowing it to remain alive and functional even as external conditions change within some range. Feedback mechanisms can encourage (through positive feedback) or discourage (negative feedback) what is going on inside the living system. (HS-LS1-3)

LS1.B: Growth and Development of Organisms

- In multicellular organisms individual cells grow and then divide via a process called mitosis, thereby allowing the organism to grow. The organism begins as a single cell (fertilized egg) that divides successively to produce many cells, with each parent cell passing identical genetic material (two variants of each chromosome pair) to both daughter cells. Cellular division and differentiation produce and maintain a complex organism, composed of systems of tissues and organs that work together to meet the needs of the whole organism. (HS-LS1-4)

LS1.C: Organization for Matter and Energy Flow in Organisms

- The process of photosynthesis converts light energy to stored chemical energy by converting carbon dioxide plus water into sugars plus released oxygen. (HS-LS1-5)
- The sugar molecules thus formed contain carbon, hydrogen, and oxygen: their hydrocarbon backbones are used to make amino acids and other carbon-based molecules that can be assembled into larger molecules (such as proteins or DNA), used for example to form new cells. (HS-LS1-6)

Systems and System Models

- Models (e.g., physical, mathematical, computer models) can be used to simulate systems and

interactions—including energy, matter, and information flows—within and between systems at different scales. (HS-LS1-2), (HS-LS1-4)

- Changes of energy and matter in a system can be described in terms of energy and matter flows into, out of, and within that system. - Investigating or designing new systems or structures requires a detailed examination of the properties of different materials, the structures of different components, and connections of components to reveal its function and/or solve a problem. (HS-LS1-1)

- Feedback (negative or positive) can stabilize or destabilize a system. (HS- LS1-3)
