## Transfer Skills

---

Students will describe the primary functions of the skeletal system (this includes comparing individual bones as well as both the axial and appendicular skeletons) and explain the functional relationships between the skeletal system and other body systems

## Learning Objectives

---

Students will be able to:

- Identify major bones in the body and their functions
- Classify human bones
- Explain how the skeleton allows for movement and flexibility of the human body
- Explain the functional importance of bone markings
- Describe the process of bone growth at epiphyseal plates
- Identify differences between the male and female skeleton
- Describe the three major categories of joints and type of movement of each
- Explain how the structure and organization of bone relates to its function in the body
- Explain how certain diseases and disorders inhibit bone function
- Discuss the interdependent nature of the skeletal system and the muscular systems

## Enduring Understandings

---

- Movement is a characteristic of living things. A study of the skeletal system is necessary to understand how a complex organism, like the human, is organized to accomplish movement.
- Bones of the skeletal system are connected together to form joints. An understanding of how joints work is basic to understanding how the body moves.
- Bones support and protect body organs; serve as levers for the muscles to pull on to cause movements

at joints; store calcium, fats, and other substances for the body; and contain red marrow, the site of blood cell production.

## **Essential Questions**

---

1. How does the skeletal system work together with muscles and nerves to achieve motion?
2. What role do tendons play in the collaborative efforts of the skeletal and muscular system?
3. What is the significance of the role of ligaments and tendons in bone articulation?
4. What are the major joints and how are they held together?

## Disciplinary Core Ideas

### LS1.A: Structure and Function

- Systems of specialized cells within organisms help them perform the essential functions of life. (HS-LS1-1)
- All cells contain genetic information in the form of DNA molecules. Genes are regions in the DNA that contain the instructions that code for the formation of proteins, which carry out most of the work of cells. (HS-LS1-1) (Note: This Disciplinary Core Idea is also addressed by HS-LS3-1.)
- Multicellular organisms have a hierarchical structural organization, in which any one system is made up of numerous parts and is itself a component of the next level. (HS-LS1-2)
- Feedback mechanisms maintain a living system's internal conditions within certain limits and mediate behaviors, allowing it to remain alive and functional even as external conditions change within some range. Feedback mechanisms can encourage (through positive feedback) or discourage (negative feedback) what is going on inside the living system. (HS-LS1-3)

### LS1.B: Growth and Development of Organisms

- In multicellular organisms individual cells grow and then divide via a process called mitosis, thereby allowing the organism to grow. The organism begins as a single cell (fertilized egg) that divides successively to produce many cells, with each parent cell passing identical genetic material (two variants of each chromosome pair) to both daughter cells. Cellular division and differentiation produce and maintain a complex organism, composed of systems of tissues and organs that work together to meet the needs of the whole organism. (HS-LS1-4)

### LS1.C: Organization for Matter and Energy Flow in Organisms

- The process of photosynthesis converts light energy to stored chemical energy by converting carbon dioxide plus water into sugars plus released oxygen. (HS-LS1-5)
- The sugar molecules thus formed contain carbon, hydrogen, and oxygen: their hydrocarbon backbones are used to make amino acids and other carbon-based molecules that can be assembled into larger molecules (such as proteins or DNA), used for example to form new cells. (HS-LS1-6)

### Systems and System Models

- Models (e.g., physical, mathematical, computer models) can be used to simulate systems and
