## Transfer Skills

---

Students will understand why the heart is an essential part of the cardiovascular system and how the various types of blood vessels function in the cardiovascular system. Students will also describe how the components of blood, structures and functions of blood components, structures and functions of the cardiovascular system, conduction system of the heart, and the cardiac cycle all maintain homeostasis in the human body.

- Describe the significance of the four-chambered heart structure.
- Explain how a heart beat is generated, regulated and changed.
- Understand the structure and roles of vessels in the human body, and explain the circulation pathway for blood.
- Discuss the interdependence of the cardiovascular and respiratory systems.
- Identify factors which put people at risk for cardiovascular disease and related disorders.

## Essential Questions

---

1. How do the various circuits of the cardiovascular system work together to sustain life?
2. What mechanisms reduce blood loss after an injury?
3. What are the major organs of the cardiovascular system and the function of each?
4. What are the major events and activities of the cardiac cycle?
5. What factors effect blood flow and pressure?
6. What are the major arteries and veins served by the heart?
7. How is blood moved through the body?
8. What factors affect cardiovascular health?

## **Learning Objectives**

Students will be able to:

- Describe the location of the heart in the human body
- Identify the major anatomical areas on a model
- Trace the pathway of blood through the heart
- Describe pulmonary and systemic pathways of circulation
- Explain the operation of heart valves
- Name/describe the cardiac conduction system
- Define systole, diastole, stroke volume and cardiac cycle
- Compare/contrast the structure/function of arteries, veins and capillaries

## Disciplinary Core Ideas

### LS1.A: Structure and Function

- Systems of specialized cells within organisms help them perform the essential functions of life. (HS-LS1-1)
- All cells contain genetic information in the form of DNA molecules. Genes are regions in the DNA that contain the instructions that code for the formation of proteins, which carry out most of the work of cells. (HS-LS1-1) (Note: This Disciplinary Core Idea is also addressed by HS-LS3-1.)
- Multicellular organisms have a hierarchical structural organization, in which any one system is made up of numerous parts and is itself a component of the next level. (HS-LS1-2)
- Feedback mechanisms maintain a living system's internal conditions within certain limits and mediate behaviors, allowing it to remain alive and functional even as external conditions change within some range. Feedback mechanisms can encourage (through positive feedback) or discourage (negative feedback) what is going on inside the living system. (HS-LS1-3)

### LS1.B: Growth and Development of Organisms

- In multicellular organisms individual cells grow and then divide via a process called mitosis, thereby allowing the organism to grow. The organism begins as a single cell (fertilized egg) that divides successively to produce many cells, with each parent cell passing identical genetic material (two variants of each chromosome pair) to both daughter cells. Cellular division and differentiation produce and maintain a complex organism, composed of systems of tissues and organs that work together to meet the needs of the whole organism. (HS-LS1-4)

### LS1.C: Organization for Matter and Energy Flow in Organisms

- The process of photosynthesis converts light energy to stored chemical energy by converting carbon dioxide plus water into sugars plus released oxygen. (HS-LS1-5)
- The sugar molecules thus formed contain carbon, hydrogen, and oxygen: their hydrocarbon backbones are used to make amino acids and other carbon-based molecules that can be assembled into larger molecules (such as proteins or DNA), used for example to form new cells. (HS-LS1-6)

## Crosscutting Concepts

### Systems and System Models
