Creative Writing 1

Credits: 2.5 Grades: 10, 11, 12

Designed as a writing workshop, this course allows students to explore their own creative potential by writing short stories and poems. Students receive basic tutelage in genre-specific style and structure. Students read and discuss model short stories and poems to assist them in developing their own writing skills. Upon completion of this course, students have a better understanding of creative writing techniques and a deeper appreciation for the writing craft. While creativity is encouraged, emphasis is placed upon the content and substance of the student's work.
