Lost Literature

Credits: 2.5

Grades 10, 11, and 12

In this course, students explore numerous stories, novels, and films that have vanished from the average literature curriculum for various reasons. While this entails reading and analyzing literature, time will also be spent examining the conditions under which this literature has been removed and the groups that wanted it erased from literary history. This course features writing and group research assignments, literature circles, film analysis, and class discussions. Novels covered in this course include: George Orwell's 1984, Kurt Vonnegut's Slaughterhouse Five, Cormac McCarthy's The Road, and Stephen King's Carrie. Join this course before it disappears.
