Students will be able to independently use their learning to improve their skills in narrative writing.

## **Enduring Understandings**

---

Scripts provide believable and easily understood scenes with dramatic potential.

Creating realistic and functional dialogue that grabs the viewer can allow for more meaningful scenes.

Writing scripts can be even more descriptive than traditional narratives as scene directions must be complete for directors and actors.

## **Learning Objectives**

---

Choose situations from their short story final project that carry dramatic potential.

Formulate plots that are believable and easily understood.

Create realistic and functional dialogue to be used within their scripts.

Design scene descriptions for directors and actors.

Format script for stage, TV or film.

Reread and analyze clarity of writing, consistency of point of view and effectiveness of organizational structure.

Add and delete examples and details to better elaborate on a stated central idea, to develop more precise analysis or persuasive argument or to enhance plot, setting and character in narrative texts.

Rearrange words, sentences and paragraphs, and add transitional words and phrases to clarify meaning and achieve specific aesthetic and rhetorical purposes.

Prepare for publication (e.g., for display or for sharing with others) writing that follows a manuscript form appropriate for the purpose, which could include such techniques as electronic resources, principles of design (e.g., margins, tabs, spacing and columns) and graphics (e.g., drawings, charts and graphs) to enhance the final product.

Use available technology to compose text.

Apply appropriate communication design principles in published and presented projects.

Create, publish and present information, utilizing formats appropriate to the content and audience.

Demonstrate an understanding of standard grammar and usage in writing and when speaking.

Demonstrate the correct use of capitalization, punctuation, and spelling.

Practice using effective choices when considering meaning and style when writing, listening, reading or speaking.

Evaluate unknown meanings in a text by using various strategies including context clues.

Practice figurative language use, word relationships, and subtle word meanings.

Expand vocabulary through speaking, listening, writing and reading.

Demonstrate the ability to maintain collaborative discussions with productive outcomes.

Review and reflect on the writing of peer texts.

Practice specific guidelines for interpreting peer texts.

Evaluate peer texts to contribute constructively.

Summarize and interpret key ideas expressed in peer texts.

Apply stylistic devices of published authors in student writing (e.g., vivid word choice, abstract versus concrete language, descriptive language, sensory details, tone, voice, persona).

Research a variety of methods and criteria for publishing original student works (e.g., school newspaper, literary magazine, online journal, school/class anthology, writing contests).

Critique creative student works throughout the writing process, using rubrics, knowledge of stylistic devices, peer review, and/or peer editing.
