### **Interdisciplinary Standards Across Content and Grade**

Fit a function to the data (including with the use of technology); use functions fitted to data to solve problems in the context of the data.

Cultural and historical events impact art-making as well as how audiences respond to works of art.
Interpersonal communication between and among people is the exchange of information and the negotiation of meaning.
Decisions or predictions are often based on data—numbers in context. These decisions or predictions would be easy if the data always sent a clear message, but the message is often obscured by variability. Statistics provides tools for describing variability in data and for making informed decisions that take it into account.
