Enduring Understandings

- Students will determine, through media literacy skills and lateral, close reading strategies when evaluating primary and secondary resources the following: 1. context of the text; 2. reason for the text; 3. type of source the text is; 4. the point of view of the author of the text 5. the intended audience for the text 6. evaluate the stance of the text
 - Students will use Historical Thinking Skills to evaluate sources and ideas. Comparison, Contextualization, Continuity and Change over Time, Periodization, Synthesis, Claims, Point of View, Intended Audience, and Purpose.
 - Students will observe, note, and draw conclusions with the understanding that there are multiple perspectives. Multiple perspectives is the foundation to understanding the why and how of history. Documents, primary sources, historical readings will be evaluated

Essential Questions

1. How did War influence the political, social and economic make-up of the global community in the 20th Century?
2. Who were the Czars of the 19th Century and how did their policies lead to the Russian Revolution of 1917?
3. What social factions developed in Russia and how did they ultimately lead to the Russian Revolution of 1917?
4. How did the establishment of the Soviet Union and the political and economic policies contrast with the Capitalist Democracies that were forming in the West?
5. How did the Treaty of Versailles and World War I ultimately create an environment that fostered the rise of dictators in Germany, Italy and the Soviet Union?
