- Students will determine, through media literacy skills and lateral, close reading strategies when evaluating primary and secondary resources the following: 1. context of the text; 2. reason for the text; 3. type of source the text is; 4. the point of view of the author of the text 5. the intended audience for the text 6. evaluate the stance of the text
  - Students will use Historical Thinking Skills to evaluate sources and ideas. Comparison, Contextualization, Continuity and Change over Time, Periodization, Synthesis, Claims, Point of View, Intended Audience, and Purpose.
  - Students will observe, note, and draw conclusions with the understanding that there are multiple perspectives. Multiple perspectives is the foundation to understanding the why and how of history. Documents, primary sources, historical readings will be evaluated.

1. What was the impact of Nixon's domestic policies and why did his administration collapsed?
2. How has the treatment of women and minorities in the U.S. from the 1970's to the present evolved? (government legislation and public opinion toward women, Spanish speaking communities, homosexuals, and African Americans, Americans with disabilities.)
3. What led to the increasing popularity of the "neo conservative" movement and what has been its impact on American society and politics?
4. What were the major reasons for the short life of the Ford and Carter presidencies?
5. What was the public atmosphere in 1980 and why it was so attracted to Ronald Reagan?
6. How successful were the presidencies of Bush and Clinton in the 1990's?
7. What are the current national issues impacting contemporary America?
