## **Essential Questions**

---

How do culture, social class and religion influence and shape one's identity?

What makes relationships between fathers and sons complex?

How do effective writers develop a character's coming-of-age throughout a novel?

What is a true friend?

## **Knowledge and Skills**

---

Students will be able to do the following:

Identify and evaluate the author's purpose and themes and their development.

Analyze setting as it contributes to the mood, atmosphere, plot, and character development. Evaluate its impact on the text.

Analyze and evaluate characters, major and minor, within text.

Recognize the use of irony within the text and characters.

Analyze form and structure of the text and evaluate their effectiveness in the text.

Analyze the effectiveness of elements of the plot, specifically foreshadowing, flashbacks, full-circle ending, and character relationships.

Understand about the racial tension between the Pashtuns and the Hazaras in Afghanistan.

Identify point of view and evaluate the effectiveness of the particular point of view.

Analyze setting as it contributes to the mood, atmosphere, plot, and character development and evaluate its impact on the work.

Recognize the use of specific tropes (figurative language, and stylistic devices including satire, humor, figurative language, description, irony, and symbols) and evaluate the effectiveness of the devices.

## **Transfer Goals**

Students will independently be able to examine how culture, social class, and religion can influence one's behavior and beliefs and apply this knowledge when analyzing historical and current events.

Students will independently be able to evaluate the effectiveness of the “full circle” ending of a novel’s structure and apply it to the future study of narratives.
