Students will understand the following:

The atrocities of genocide are not only conveyed in text but are also revealed through the voices of witnesses and primary accounts.

Essential Questions

How may silence perpetuate violence?

How do graphic novels allow for a more effective use of symbolism?

How does knowledge of the past enable people to make better decisions about the future?

What is the importance of memory and remembrance in relation to genocide?

Knowledge and Skills

Students will identify some of the major events of the Holocaust as told by Art and Vladek Spiegelman.

Students will supply the meanings of unfamiliar words used in the book.

Students will identify themes and issues presented in the book.

Students will identify character traits of the major characters.

Students will analyze the use of animals as symbols.

Students will analyze the use of graphics in the book and their relationship to the text and the story.

Students will use quotes from the text to stimulate discussion and support statements.

Transfer Goals

Students will independently be able to analyze how important symbols reinforce underlying themes and apply that knowledge to the future study of graphic novels.

Students will independently be able to recognize visual rhetoric such as political cartoons, graphic novels, and propaganda in order to be aware of its ability to persuade and manipulate individuals.
