## **Knowledge and Skills**

---

Learn about Proclamation 9066 signed by FDR in 1942 ordering the internment of Japanese living in the United States and Japanese-American citizens.

Understand the apparent willingness of Japanese Americans to accept and follow Proclamation 9066.

Examine the journey to the internment camps and the treatment of the people by the US government while they were interned.

Evaluate the utility of the camps and how this event is viewed through a historical lens.

Examine how syntax and isolating imagery of the external setting reflect the internal feelings of characters in the novel.
