Essential Questions

- How do you determine that something is a fact?
- How do you determine that something is an opinion?
- What are some text features used in books to help you understand the text/article better?
- What are the 3 author's purposes for writing a book? What does each mean?
- What is a way to determine importance between two texts on the same topic?
- Why are text features used in non-fiction texts/articles?

Enduring Understanding

- A fact is a statement that can be proven by testing it, checking a source, or asking an expert.
- An opinion is how someone feels or believes (an opinion). Some key words for opinions are: I believe/think, like/dislike, I think, I prefer, in my opinion, etc.
- Headings are used to tell you what the following text will be about (the details). Other text features are bold words, labels, and captions.
- One way to determine importance on two texts on the same topic is to compare and contrast events

and/or characters from two texts. Using a Venn Diagram is a great visual for formulating this comparison.

- Text features are used in non-fiction texts/articles to help the reader understand the important parts of the book.
- The 3 different kinds of author's purpose are: PIE. Persuade is to convince the reader of a certain point of view. I is to inform the reader about a topic (facts). Entertain is to tell a story which includes characters and setting.

Content

Students will be able to:

- determine the difference between a fact and an opinion
- determine the author's purpose for their writing using the PIE model
- use text features to help understand the text
- find 3 important details to identify each heading
- use key details to identify the main idea
- compare/contrast the adventures and experiences of characters in stories;
- compare/contrast basic similarities and differences between two texts on the same topic
