Unit Overview

The unit will address:

- The use of tone and mood;
- The use of foreshadowing for heightening suspense;
- The creation of interest with the use imagery, suggestive titles of each chapter and "cliff hangers;
- The connection between primitive man's "fight or flight" response and our present day response to danger;
- Terror and horror being intricately connected, and the literature that reflects that connection;
- The necessity for "suspension of disbelief;"
- The classic authors of horror writing;
- A world that has become desensitized to horror literature.

Enduring Understanding

- Mankind has always been captivated by "the ghost story.
- The "monster under the bed" story, whether told when sitting around a campfire, when at a sleepover with friends or when riding on the bus next to a stranger who has a story to tell is spell-binding.
- Fear is an integral component of the human psyche.
- Through reading and movies, man can see/experience fear in a way that's different from our normal lives.

Essential Questions

- What are the characteristics of classic horror piece?
- Why do some authors become "classic" authors?
- What are the elements of good characterization?
- How does characterization support the plot?
- How does character conflict differ in the supernatural literature?
- Why is "suspension of disbelief" paramount to the enjoyment of supernatural fiction?



Suggested Activities & Best Practices

- Students can keep a response journal, recording their reactions to the stories. They can select their own topics or respond to the questions below.
- The response journal might be followed up with students working in reading groups. Students who have read the same story can share their ideas and, thereby gain other insights into the story.
- These questions are appropriate to discuss or write about after reading any of the suggested short stories:
 - What is the nature of evil?
 - What is the embodiment of evil in the story?
 - How does King develop the suspense in the story?
 - What elements of surprise are built into the story?
 - Who is the protagonist? Is she or he a victim? How does King make you empathize with the protagonist?
 - Who or what is the antagonist? When do you discover who the antagonist is? How do you feel after you discover this?
