## **Unit Overview**

---

This unit provides an introduction to the basic guidelines for all the first aid topics. First aid is not full and complete treatment, but rather "immediate care that is given to the victim of an injury or illness to minimize the effect of the injury or illness until experts can take over." Students are encouraged to get certified in basic first aid and CPR which will be extended to all students through a teacher discovered opportunity. (payment may or may not be required)
