Unit Overview

The second unit of the year focuses on the bildungsroman and magical realism. Students will compare their own coming-of-age stories to those of the novels' teenage protagonists, who struggle to find meaning in a world that just doesn't seem to understand. The characters' daydreams begin to affect the "real world," complicating their already troubled lives by blurring the line between fantasy and reality. In Gene Luen Yang's American Born Chinese, the journey of the Chinese folk hero Sun Wukong is juxtaposed with the modern-day struggles of a so-called ABC teenager. In I Kill Giants, by Joe Kelly and JM Ken Nimura, a precocious (yet troubled) 5th grader escapes into Dungeons & Dragons-inspired fantasies to escape the darkness in her life. As students read and write about these characters' struggles, they will continue to analyze the ways in which the visual nature of medium further enhances literary techniques such as tone, mood, and point of view. Students will learn how comic artists convey time and motion through static images, and how the mind interprets these visual abstractions as "the real thing."



Suggested Activities & Best Practices

Students will complete regular journal prompts for assigned readings and write breakdowns and translations for specific scenes, in which they will analyze select scenes by deconstructing them down to their individual shots/transitions and write narrative translations of the silent sequences of images, complete with character's thoughts and dialogue. This will enhance their critical thinking skills, writing, and creativity.

Students will be required to read at least one supplemental text per marking period. They may choose from a recommended list or submit a book for approval. Students will be required to complete a reading log and a book review for each choice book. Every student will sign up to present at least one book review to the class before the end of the year. This will encourage students to read outside the classroom and in turn hopefully boost reading skills.
