Unit Overview

The first unit will serve as an introduction to the graphic novel as a genre and art form. Students will study a brief history of comic art while building a specialized vocabulary of literary, cinematic, and comic terminology. The primary texts for this unit will be "silent" graphic novels that have no words.

Enduring Understanding

- 1. Comics/graphic novels borrow from visual art and literature in ways that allow them to create unique reading experiences
- 2. Even the most fantastic story can be related back to life in the "real" world
- 3. "True" happiness is relative and is different for everybody
- 4. Success requires sacrifice

5. An author's intended meaning for a text is only one of many

Essential Questions

- 1. What separates the comic/graphic novel from visual art and literature?
- 2. How can art act as both "a window" into our world and "an escape" from our world?
- 3. How does the artistic process (from idea to realization) influence the meaning of a work?
- 4. What is the relationship between form and function?
- 5. How can allegories shed light on life in the "real" world?

- 1. Define comic, cartoon, and graphic novel and distinguish among them
- 2. Identify major works of comic art throughout history and explain their significance
- 3. Draw and write examples of icons and symbols in everyday life
- 4. Explain how and why abstract, "unrealistic" icons are able to resonate with readers

Learning Objectives

- -Deconstruct scenes into individual shots.

- -Write essays that include strong thesis statements, relevant evidence from a text, and thorough explanation and analysis of the evidence.
- -Write scene breakdowns that explain techniques used in visual narratives

Suggested Activities & Best Practices

Students will complete regular journal prompts for assigned readings and write breakdowns and translations for specific scenes, in which they will analyze select scenes by deconstructing them down to their individual shots/transitions and write narrative translations of the silent sequences of images, complete with character's thoughts and dialogue. This will enhance their critical thinking skills, writing, and creativity.

Students will be required to read at least one supplemental text per marking period. They may choose from a recommended list or submit a book for approval. Students will be required to complete a reading log and a book review for each choice book. Every student will sign up to present at least one book review to the class before the end of the year. This will encourage students to read outside the classroom and in turn hopefully boost reading skills.


