Unit Overview

In this Unit students will learn and develop public speaking and oral advocacy skills. This Unit will cover several forms of public speaking, and offer students a chance to develop the elements that go into an effective persuasive speech of any type. Students will learn the art of advocacy; to persuade any audience of the merits of a cause or proposal and of the credibility of the proponent.

The Unit is designed to help students improve their ability to communicate persuasively in a wide variety of settings in which individuals are called upon to speak including client meetings, business negotiations, and presentations to public agencies. Students will work independently and in cooperative groups to create a coordinated and persuasive oral presentation. The Unit will offer students an opportunity to hone their presentation skills, and include instruction in areas such as effective performance techniques, writing for speaking and the ability to handle difficult speaking situations.

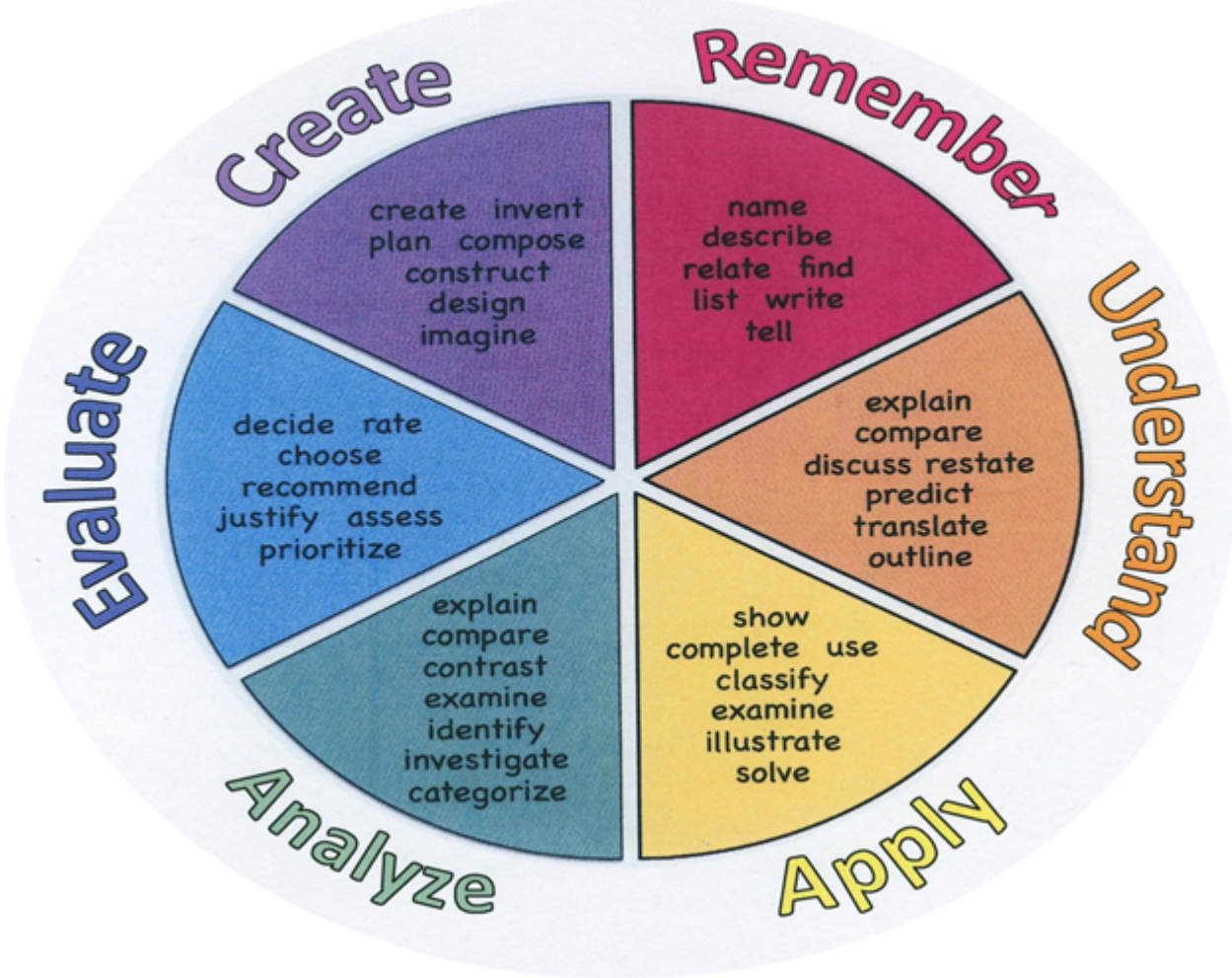
