Unit Overview

Whether or not a society is perceived as a dystopia is usually determined by one's point of view; what one person may consider to be a horrible dystopia, another may find completely acceptable or even nighutopian. Many societies in fiction are depicted as utopias when in fact they are dystopias; like angels and demons, the two are sides of the same coin. This seemingly paradoxical situation can arise because, in a dystopia, the society often gives up one thing in exchange for another. The loss of the first thing is not felt until years later and citizens come to realize that the world they once thought acceptable (or even ideal) is not the world they thought it was. That's part of what is so compelling—and insidious—about dystopian fiction: the idea that you could be living in a dystopia and not even know it.

Enduring Understanding

Uptian societies may be possible but they may be attained at a very high price and may eventually lead to a dystopian society. Ours words, thoughts, actions, may cause us to break from general society and norms in an effort to obtain this perfect world.

Essential Questions

Why do people continue to pursue the concept of a utopian society?

Is utopia attainable? At what cost would it be worth attaining?

Exit Skills

- Students will be able to compare the utipian/dystopian societies in "Brave New World" and "The Handmaid's Tale" and see how much of it is actually attainable or even present in today's world and society.
- Write a composition comparing/contrasting societies and choosing which to live in if given the choice.
- Participate in a class debate on the creation of a utopian society.



- Analyze the structural writing process by examining how the novels are arranged and determining how its arrangement impacts its plot and character development.
- Evaluate the impact of historical feminism on the novel.
- Evaluate and identify with the central character through examining her strengths and weaknesses.
- Examine the author's use of ambiguity in the novel, particularly as it relates to language and identity,
- Discuss motifs and themes as they emerge and relate to the prior Units studied.
