## **Unit Overview**

---

Throughout Unit 2: The Individual and Society, as you read and discuss the selection in this unit, students will improve their skills in reading, writing, research, language, and speaking. Students will explore some of the dilemmas people face as they establish themselves both as individuals and as members of a group, and as they define themselves and are defined by others.

## **Enduring Understanding**

---

### **Reading**

By reading and evaluating nonfiction narratives and reading arguments and informative essays, student will better understand the

ways writers express ideas.

### **Writing and Research**

By learning the elements of writing a nonfiction narrative and writing their own nonfiction narrative, students will organize and share ideas, reflect on experiences and gather evidence and research to clarify and explore ideas.

### **Language**

By developing a deeper understanding of effective style choices regarding diction and sentence variety, students will practice correct usage of concrete, abstract, and compound nouns in their own writing.

### **Speaking and Listening**

By working together to build on one another's ideas, develop a consensus, and communicate with one another students will learn how to incorporate audio, visuals, and text in presentations.
