## **Unit Overview**

---

Unit 3: Writing for Different Forms of Publication explains how to write different types of news articles including editorials, columns, and features. The unit will describe types of organizational styles for news and feature stories, and how to achieve tightly written news. Students will explore how each type of written work is categorized and what are the purposes of each of these pieces are in journalism.

## **Enduring Understanding**

---

1. Feature writers have more flexibility, and they are allotted more creativity than other reporters.
2. Defining a subject, identifying the message, deciding how to present your message, putting the story together, and finishing the story are the five steps to creating the feature article.
3. Opinion writers use the editorial page to advance an argument or discuss important issues of the day.
4. Editorials play a major role in stimulating debate and discussion.
5. Columns give writers flexibility in which they have license to use humor or lay out sharp insights to the reader.
6. Columns give the writer the opportunity to combine opinion with supportive facts and transfer a message to the writer's audience.

- What methods of brainstorming and planning are necessary for effective news writing?
- What is the most effective means of revising and editing a piece of writing?
- How are reporting and researching utilized in composing articles and opinion pieces?
- How does word choice and sentence structure impact meaning, readability, and interest?
- How can grammar and punctuation change meaning?
