Unit Overview

Throughout Unit 3: Power, Protest, and Change, you will encounter people, real and fictional, who are protesting various injustices. Student will explore how much of a difference people can make in addressing the problems of society's past, present, and future and what makes their voices uniquely powerful.

Enduring Understanding

- By examining informative text, speeches, public documents, fiction, articles, and poems students will gain an understanding of and insight into the ways writers express ideas.
- By learning the elements of an explanation and writing their own informative essays students will clarify and explore ideas by conducting research.
- By examining how writers use phrases and clauses students will demonstrate their deeper understanding of these elements in their own writing.
- By working together to build on one another's ideas, developing consensus, and communicating with one another students

will learn to incorporate audio, visuals, and text in presentations.

Essential Questions

- In what ways does the struggle for freedom change with history?
- How do individuals contribute to change?
