Unit Overview

Throughout this unit, students will come to understand how to prevent a collision, driver hazards (distraction and tiredness) and communication. They will also learn how to identify road and environmental conditions that impact drivers, how to react to driver problems and emergencies, and how to describe avoiding collisions and reacting to collision situations.

Students will know New Jersey State Licensing Procedure Rules and Laws.

Students will learn driving Speed and parking Regulations.

Students will learn night driving skills.
Students will learn skills driving in poor weather.
Students will learn collision prevention skills.
Students will learn the difference between defensive driving and road rage.

Essential Questions

What are the important laws and restrictions for drivers with a permit?

What are important laws and restrictions for those with a probationary license?

Why is it important to learn defensive driving maneuvers?

How do night time and poor weather present a challenge to drivers?

How could you promote safe driving habits to your peers?

What are some safe driving habits you think all drivers should have?

What should you do to avoid collisions?

How do driving distractions lead to collisions?

What are ways to handle various emergency driving situations?

Exit Skills

By the end of Unit 3, the student should be able to:

Identify the graduated driver's license safety related laws.

Create posters promoting defensive driving.

Identify the impairments alcohol causes to the body and how this affects the ability to drive.

Explain the various laws involved with driving such as parking distances, following distances, stopping distances, turning, and all other laws regarding safe driving habits.

Apply defensive driving skills to emergency situations.

Promote safe driving habits to their peers through a variety of media forms.

Evaluate current driving laws and debate if they are effective or need to be altered identifying why if so.

Create presentations on emergency driving situations and teach others how to handle these situations. Identify ways to help others become more aware of laws, including the Move Over Law.

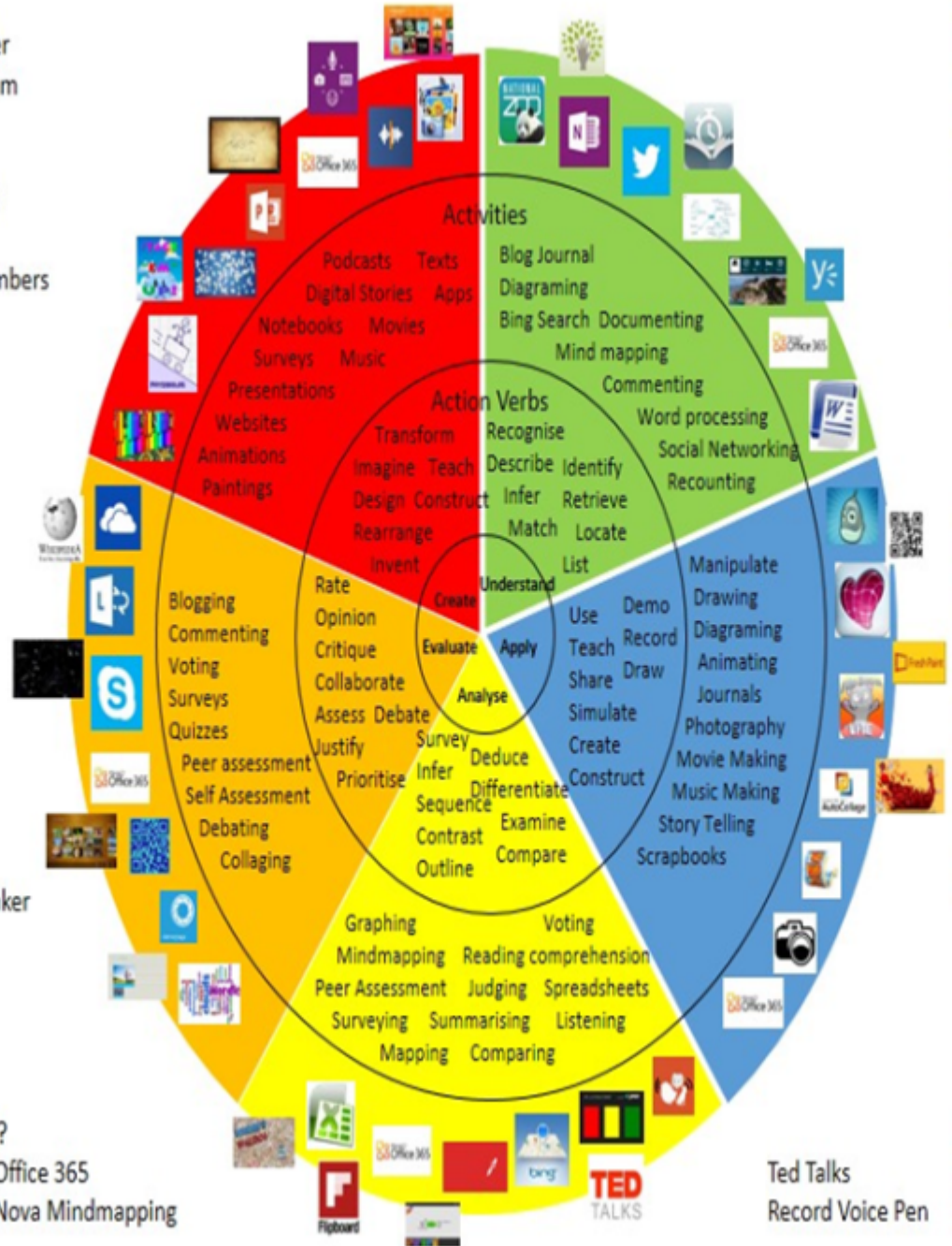

Unit Name: Defensive Driving

Interdisciplinary Connection: Language Arts

Statement of Objective: SWDAT understand, compare, contrast, utilize and apply information as it pertains to distracted driving in order to create an informational project (slideshow, PSA, infographic, poster) warning of the dangers of distracted driving.

Anticipatory Set/Do Now: Consider an accident that you witnessed or heard about on the news. What type of accident was it (rear end, side collision)? Based on what you know, who would be at fault? What factors would contribute to this type of accident? How could the accident damage have been minimized or even avoided?

Learning Activity: partner project, students will work together to conduct research and create an informational project that highlights the dangers of distracted driving
