## **Unit Overview**

---

1. Gases respond in predictable ways to pressure, temperature, volume, and change in number of particles.
2. Every chemical reaction proceeds at a definite rate, but can be sped up or slowed down by changing the conditions of the reaction.
3. Acids and bases can be defined in terms of hydrogen ions and hydroxide ions or in terms of electron pairs.
4. Students begin to examine the ways that human activities cause feedbacks that create changes to other systems. Students understand the *system interactions* that control weather and climate, with a major emphasis on the mechanisms and implications of climate change.
5. Students model the flow of energy and matter between different components of the weather system and how this affects chemical cycles such as the carbon cycle. Engineering and technology figure prominently here, as students use mathematical thinking and the analysis of geoscience data to examine and construct solutions to the many challenges facing long-term human sustainability on Earth.
6. Here students will use these geoscience data to explain climate change over a wide range of timescales, including over one to ten years: large volcanic eruption, ocean circulation; ten to hundreds of years: changes in human activity, ocean circulation, solar output; tens of thousands to hundreds of thousands of years: changes to Earth's orbit and the orientation of its axis; and tens of millions to hundreds of millions of years: long-term changes in atmospheric composition).

## **Enduring Understanding**

---

1. Changes in the atmosphere due to human activity have increased carbon dioxide concentrations and thus affect climate.
2. The foundation for Earth's global climate systems is the electromagnetic radiation from the sun, as well as its reflection, absorption, storage, and redistribution among the atmosphere, ocean, and land systems, and this energy's re-radiation into space.
3. Changes in the atmosphere due to human activity have increased carbon dioxide concentrations and thus affect climate.
4. The total amount of energy and matter in closed systems is conserved.
5. The total amount of carbon cycling among and between the hydrosphere, atmosphere, geosphere, and biosphere is conserved.
6. Students will learn about the behavior of gases. This will translate to a greater understanding of the everyday life. The gas laws are key to a deep understanding of weather, balloons, diving, and climate change.
7. Students will gain knowledge about why reactions happen at a fixed rate. Why the body requires enzymes to catalyze reactions. By what mechanism do reactions create products on a molecular level.
8. Students will be able to identify what household products are acids vs bases. How pH can convey a great deal of information about a solution.

- How would temperature affect the rate of a chemical reaction?
- What is the difference between an acid and a base?
- What makes an acid or base strong?
- What information can one acquire from the pH scale.

Mathematically proficient students can apply the mathematics they know to solve problems arising in everyday life, society, and the workplace. In middle grades, a student might apply proportional reasoning to plan a school event or analyze a problem in the community. By high school, a student might use geometry to solve a design problem or use a function to describe how one quantity of interest depends on another. Mathematically proficient students who can apply what they know are comfortable making assumptions and approximations to simplify a complicated situation, realizing that these may need revision later. They are able to identify important quantities in a practical situation and map their relationships using such tools as diagrams, two-way tables, graphs, flowcharts and formulas. They can analyze those relationships mathematically to draw conclusions. They routinely interpret their mathematical results in the context of the situation and reflect on whether the results make sense, possibly improving the model if it has not served its purpose.

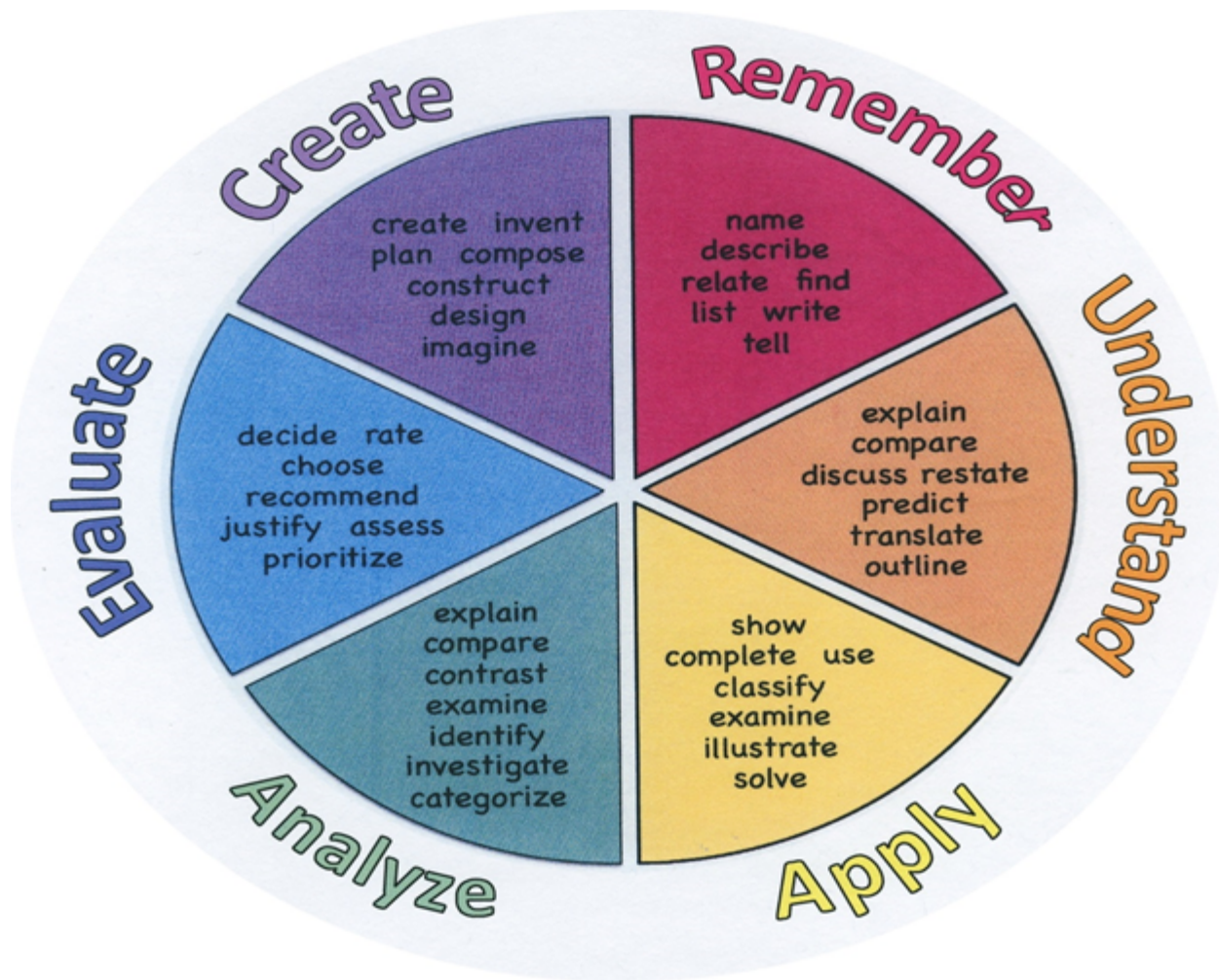
