Unit Overview

In this unit, students will focus on the following topics as they relate to periodic properties of the elements:

- The development of the periodic table
- Electron configurations: How electrons occupy orbitals
- Electron configurations: Valence electrons, and the periodic table
- The explanatory power of the quantum-mechanical model
- Periodic trends in the size of atoms and effective nuclear charge
- Ions: Electron configurations, magnetic properties, ionic radii, and ionization energy
- Electron affinities and metallic character
- Examples of periodic chemical behavior: the alkali metals, the halogens, and the noble gases

Enduring Understanding

1. Representations and models can be used to communicate scientific phenomena and solve scientific problems.

3. Scientific questioning can be used to extend thinking or to guide investigations within the context of the AP course.

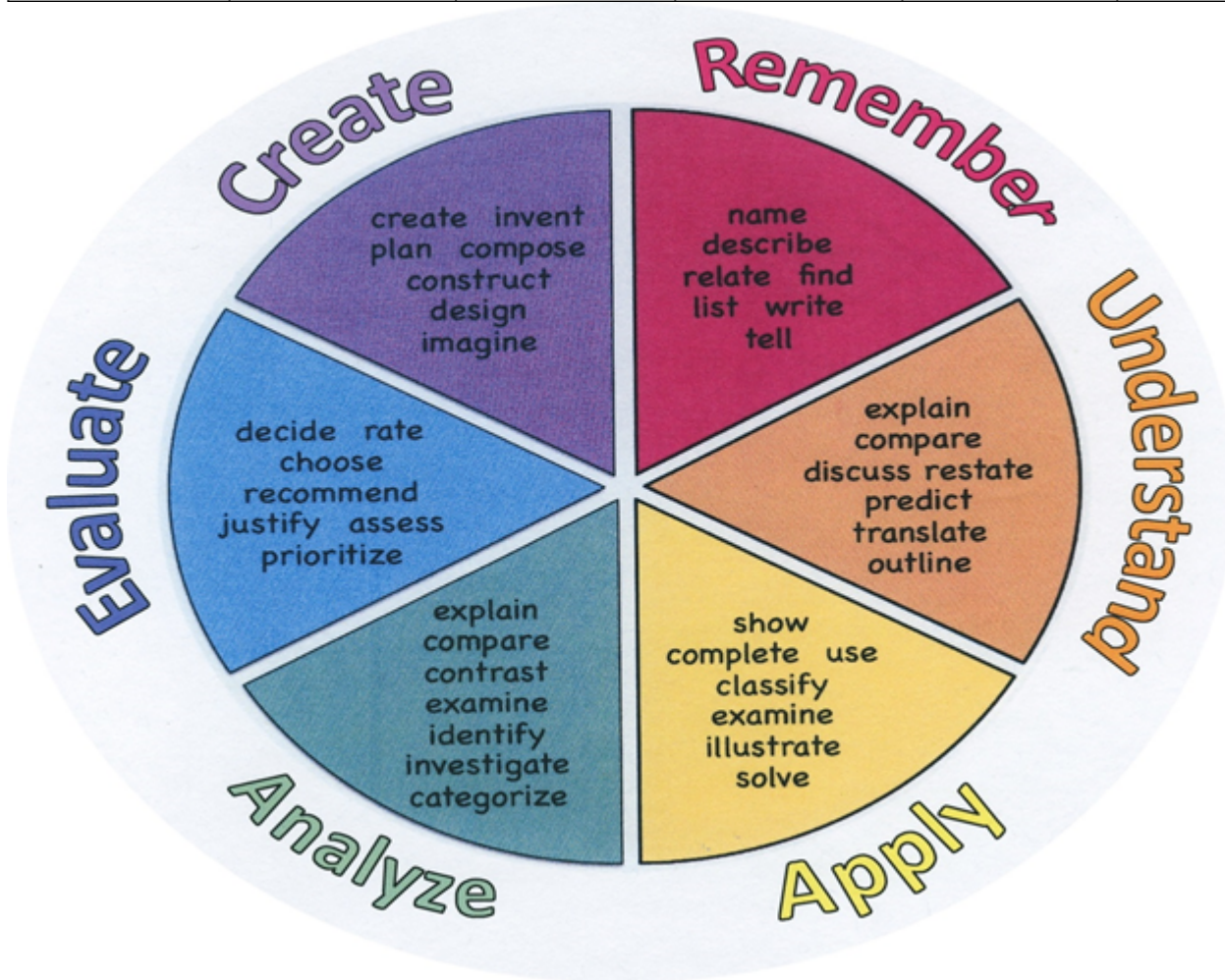
Learning Objectives

1. The student is able to analyze data relating to electron energies for patterns and relationships.
2. The student is able to describe the electronic structure of the atom, using PES data, ionization energy data, and/or Coulomb's Law to construct explanations of how the energies of electrons within shells in atoms vary.
3. The student is able to explain the distribution of electrons using Coulomb's Law to analyze measured energies.
4. The student is able to predict and/or justify trends in atomic properties based on location on the periodic table and/or the shell model.
5. Students can justify with evidence the arrangement of the periodic table and can apply periodic properties to chemical reactivity.
6. The student can analyze data, based on periodicity and the properties of binary compounds, to identify patterns and generate hypotheses related to the molecular design of compounds for which data are not supplied.
7. The student is able to explain why a given set of data suggests, or does not suggest, the need to refine the atomic model from a classical shell model with the quantum mechanical model.
8. Given information about a particular model of the atom, the student is able to determine if the model is consistent with specified evidence.
9. The student is able to apply Coulomb's Law qualitatively (including using representations) to describe the interactions of ions, and the attractions between ions and solvents to explain the factors that contribute to the solubility of ionic compounds.
