Unit Overview

In this unit, students will be able to describe and explain the ways that motion is affected during collisions and other interactions with other systems. Students will apply the concepts of momentum and energy to motion problems in order to conceptualize and quantify inter-system interactions. Prior knowledge will be used to build new connections to mathematical relationships and interconnected quantities of motion, momentum, and energy.

Enduring Understanding

- Work is done when a force causes an object to move. This meaning is different from the everyday meaning of work.
- Power is the rate at which work is done.
- The mechanical advantage of a machine describes how much the machine multiplies force or increases distances.
- Energy is the ability to do work.
- Energy readily changes from one form to another.
- Students will relate to their Interactions with other objects or systems can change the total linear momentum of a system.
- The linear momentum of a system is conserved.
- The angular momentum of a system is conserved.

Essential Questions

What are the different ways energy and momentum affect the motion of objects?

How do physicists describe collisions?

How do physicists describe machines and mechanical systems in terms of work, power and energy?

Will students be able to find real life uses for simple machines?

Are students able to explain leverage in simple machines?

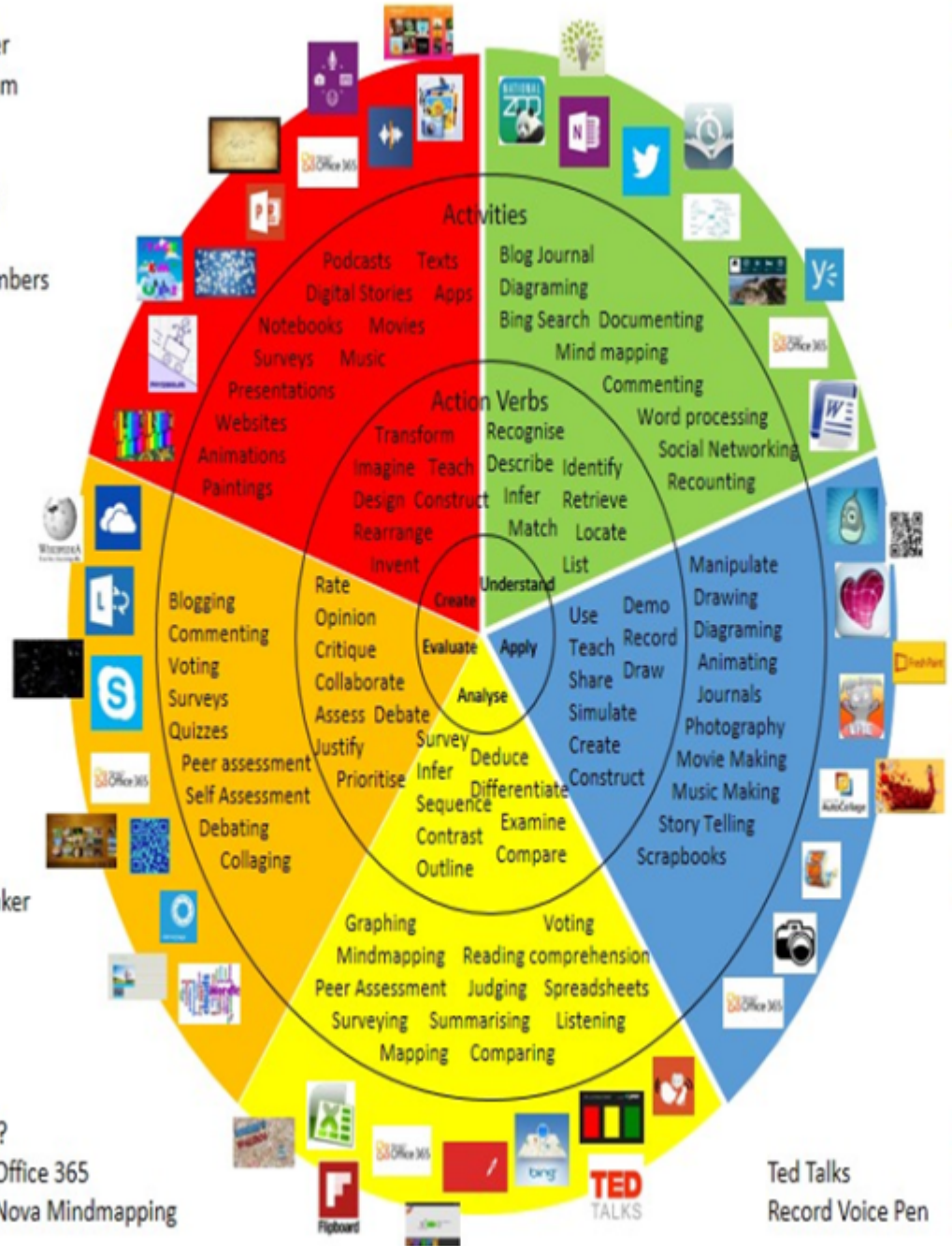
