Unit Overview

Unit 4 examines how the media influences a viewer's choice of whether or not to use drugs and alcohol; the steps to making good decisions; and the legal and personal consequences of poor decision making.

Enduring Understanding

1. The legal ramifications associated with drugs.
2. Media is a pervasive influence on the choices one makes with using drugs and alcohol.
3. There are legal alternative medicines available. People tend to self-medicate with drugs and alcohol.
4. The legal and personal consequences of drinking and driving are life changing.
5. The steps to making good decisions.
6. The legal issues if you are charged with possession.

Essential Questions

1. What are the legal issues associated with drugs?
2. How does the media influence the choices and decisions one makes with drugs and alcohol?
3. What alternative medicine is available?
4. What are the consequences of drinking and driving?
5. What are the steps involved with making good decisions?
6. What will happen if you are charged with possession?
7. What would happen if you were under the influence of drugs or alcohol?

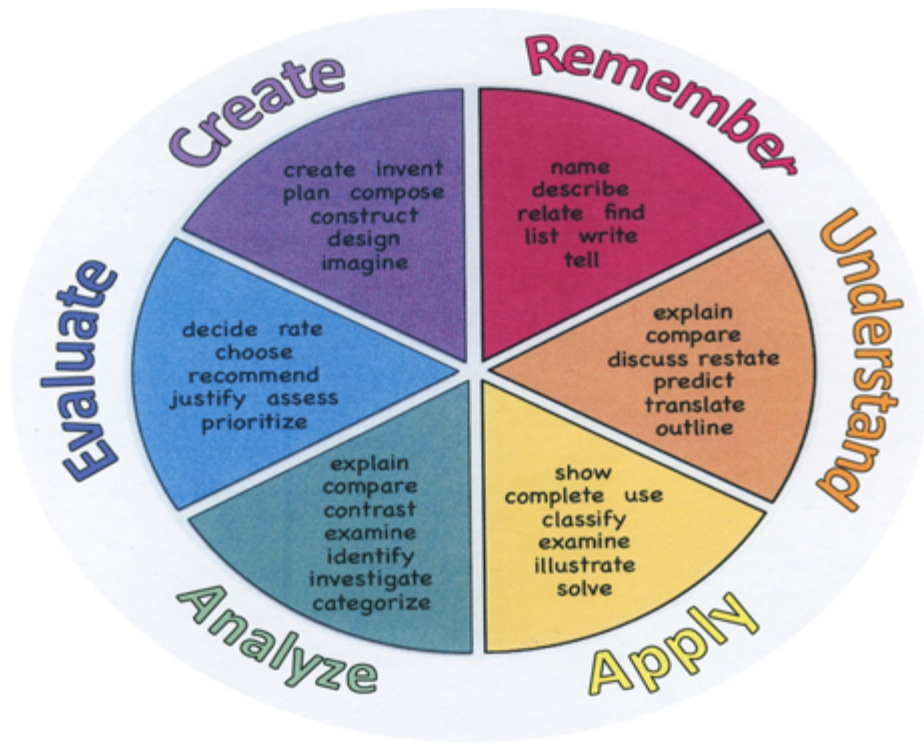

 - allowing students to correct errors (looking for understanding)
 - teaching key aspects of a topic. Eliminate nonessential information
 - allowing products (projects, timelines, demonstrations, models, drawings, dioramas, poster boards, charts, graphs, slide shows, videos, etc.) to demonstrate student's learning
 - allowing students to select from given choices
 - allowing the use of note cards or open-book during testing
 - collaborating (general education teacher and specialist) to modify vocabulary, omit or modify items to reflect objectives for the student, eliminate sections of the test, and determine how the grade will be determined prior to giving the test.
 - decreasing the amount of work presented or required
 - having peers take notes or providing a copy of the teacher's notes
 - marking students' correct and acceptable work, not the mistakes
 - modifying tests to reflect selected objectives
 - providing study guides
 - reducing or omitting lengthy outside reading assignments

 - tutoring by peers
 - using authentic assessments with real-life problem-solving
 - using true/false, matching, or fill in the blank tests in lieu of essay tests
 - using videos, illustrations, pictures, and drawings to explain or clarify
