Unit Overview 3

Essential Questions

How has slavery shaped the Southern economy, culture, and society?

Who had the advantage in the Civil War?

What were the key battles and people of the Civil War?

What were the differing opinions of reconstructing the South?

Exit Skills

The students will:

- Define Manifest Destiny and explain how this was fulfilled in Texas, in Oregon, and in the Mexican Cession.
- Evaluate the extent to which manifest destiny was racist and/or paternalistic.
- Explain how our expansion reopened the debate over slavery.
- Describe the interrelationships between territorial expansion and the slavery question.
- Contrast the slavery positions of the abolitionists with those of the Southern planters.
- Describe the social structures that existed in the North and in the South in the pre-war period.
- Analyze the 'drift toward disunion' occurring in the 1850's; explain key events.

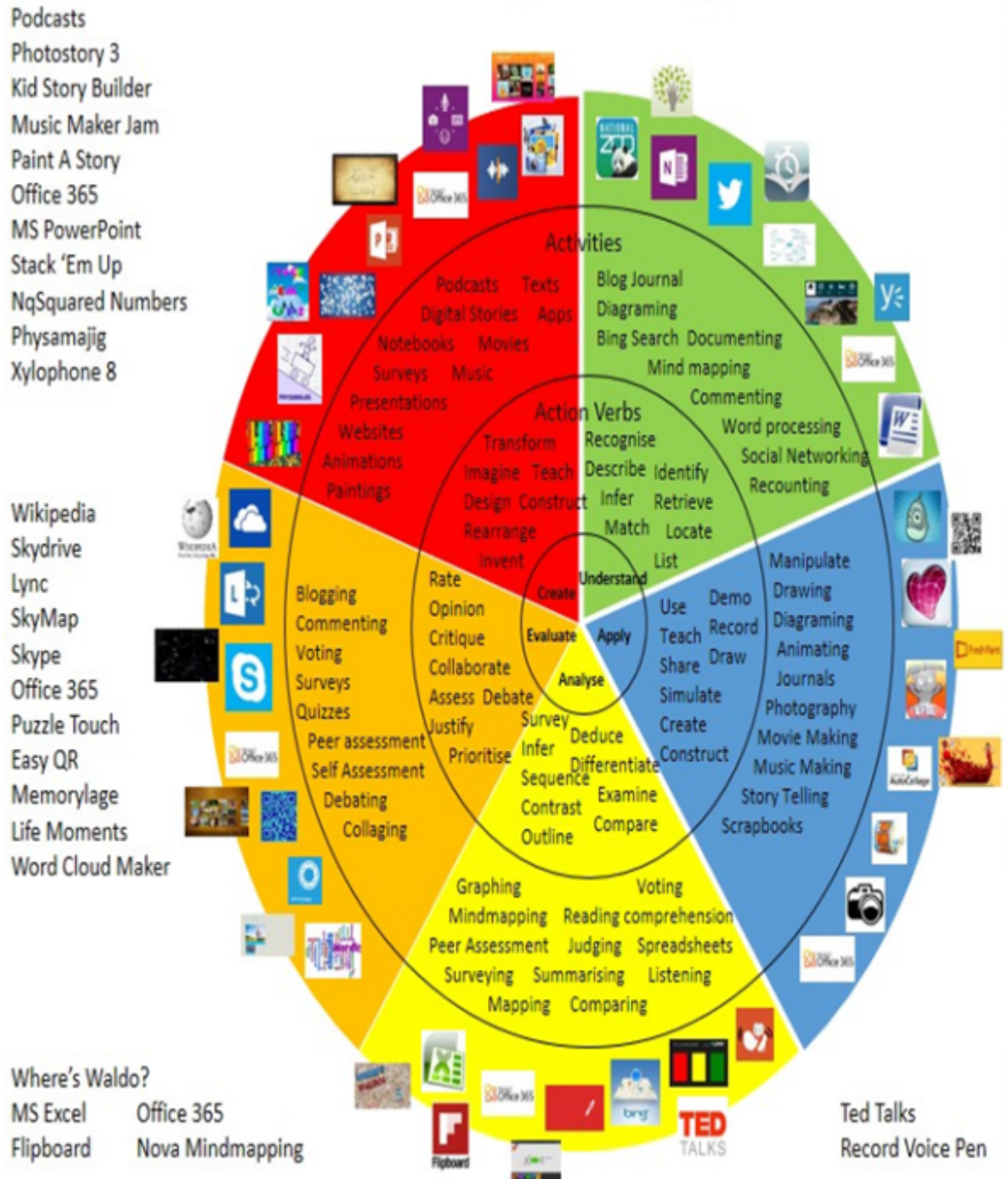
