Unit Overview

The theme for this unit is Payroll, taxes and forms. Students are introduced to the accounting practices and concepts of managing payroll records and taxes. Emphasis is placed on calculating employee earnings, determining payroll tax withholding, preparing records, payroll checks and related accounting, taxes and payroll reports.

Enduring Understanding

- Calculating Payroll and related taxes is a process by which we, as individuals assess gross vs. net pay
- Calculating Payroll and related taxes from a business perspective is a process by which a company assess withholding
- Students, throughout their lives will realize accounting concepts and practices related to payroll in

both, personal and business scenarios

- Explore careers in accounting as related to taxes

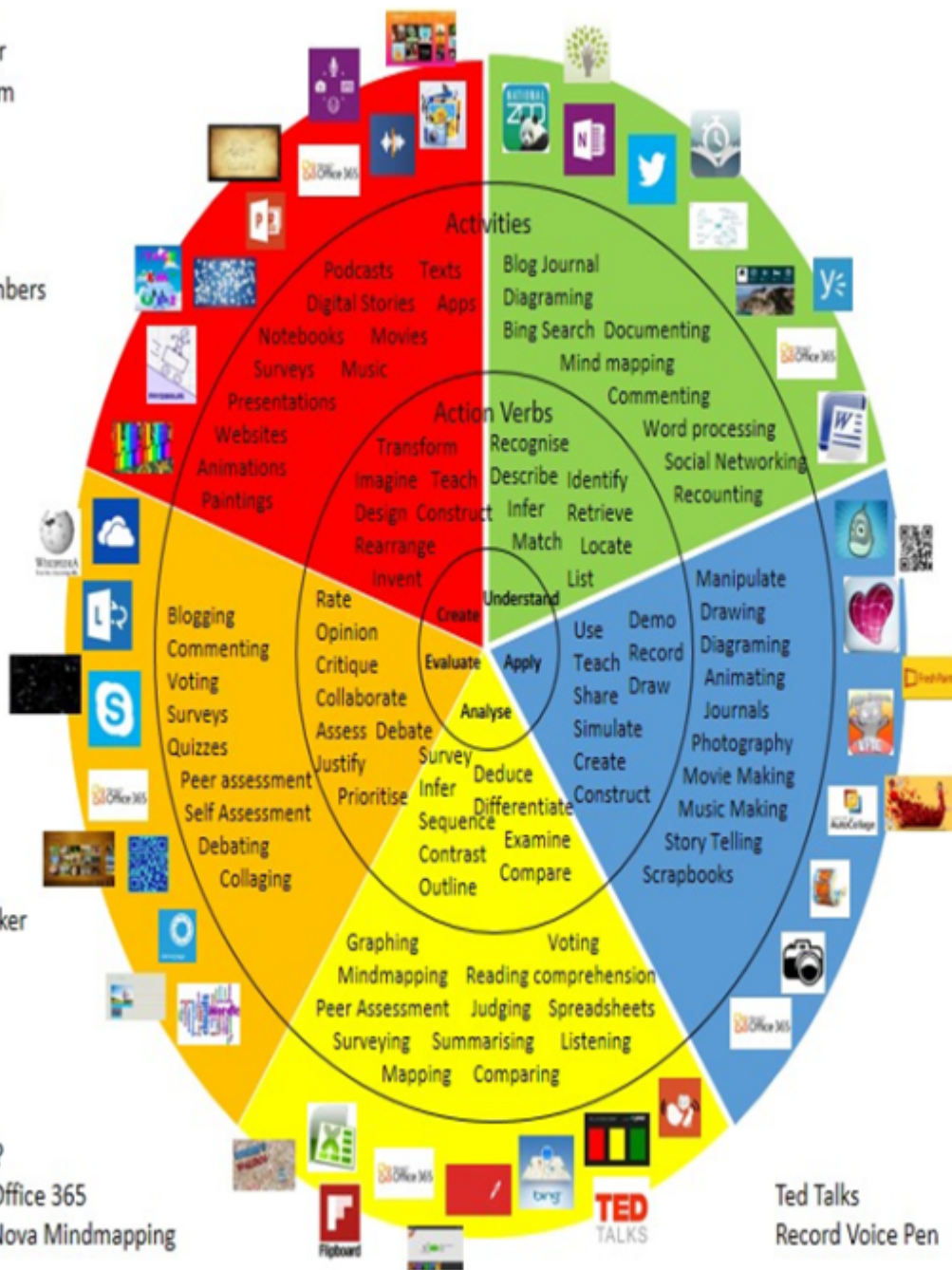
