### **Philosophy of the Career and Technical Education Department**

All students who complete a career and technical education program will acquire academic and technical skills for careers in emerging and established professions that lead to technical skill proficiency, credentials, certificates, licenses, and/or degrees.

Students are required to successfully participate in class, complete all homework assignments and any class projects/ assignments/ papers, maintain a notebook, and pass teacher prepared tests and quizzes.

A grade of a “C” or higher must be achieved in order to pass/ continue in the cosmetology program.

Students must have completed 1,000 hours in the cosmetology program by the conclusion of their senior year. They will be prepared to pass their state board written and practical licensing exam.

### **Course Description**

Cosmetology is a multi year program designed to assist the student in developing skills that are used by cosmetologists/hairstylists. In this area each student must meet a minimum number of classroom hours in order to complete the program; therefore attendance is critical. This program may lead to a state license to practice cosmetology in the state of New Jersey. Course work in shop includes all basic skills of cosmetologists such as: basic haircutting, pin curling, finger waving, permanent waving, roller sets, and hairstyling. Also, basic manicuring, hair removal procedures, salon management, and sanitary procedures. Scientific and artistic concepts are covered in theory in order to prepare students for STATE BOARD license exam upon successful completion of program and mandatory 1,000 hours. Recommended sequence of course is Cosmetology I – sophomore year, Cosmetology II- junior year, and Cosmetology III- senior year. The Cosmetology course- will enable the student to work in the field as a cosmetologist/ hairstylist, manicurist/nail technician, esthetician (facialist/skin care/ make-up artist).
