## **Unit Overview**

---

Unit 4, Creative nonfiction, begins with facts-what actually is or was, or what actually is happening or has happened. It is then described and discussed in a creative way. This issue-based unit asks students to read about and think abstractly about societal issues and the concrete problems these issues generate. After brainstorming about social conflicts and their associated problems, students will select the most viable topic that interests them and perform Web research to become experts on their issue to develop a strong stance. These issues can be vetted from, but not limited to: Scope Magazine, conflicts from novels, the news, science or social studies topics. Students will collect evidence that supports their stance and deliver their message through the genre of creative fiction. Author's purpose may be to either: raise awareness; to present a solution to a problem; to get the audience to see the issue from the writer's perspective. The unit ends with one polished piece added to the portfolio.

(brainstorming, discussion, drafting).

Research requires selecting credible sources, sifting information to find the most effective evidence, and fluidly incorporating that evidence into the piece.

The intended audience influences the tone of a writing piece.

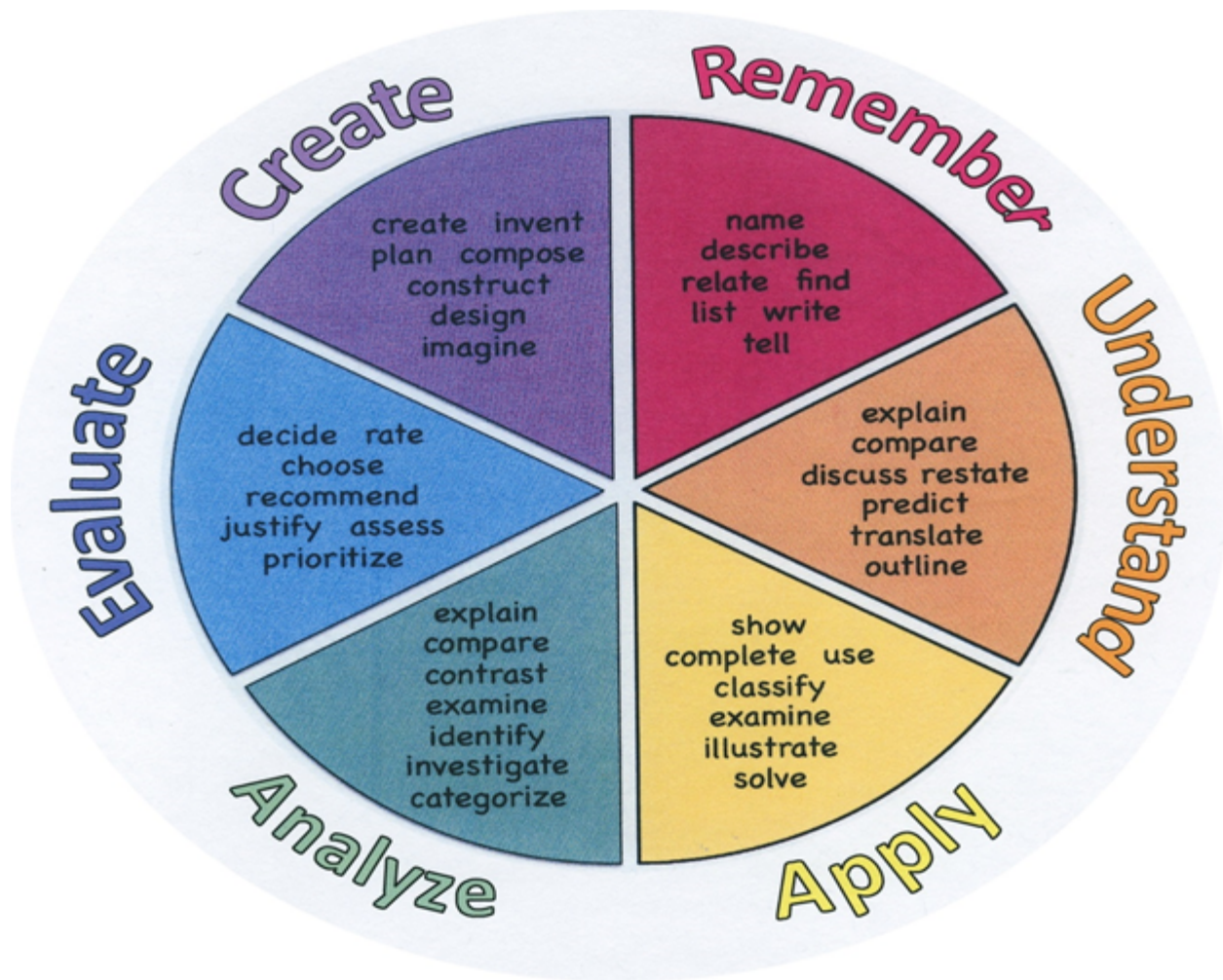
