### **Unit Overview**

Unit 5: Forms of Journalism includes learning about the different journalistic styles of reporting and writing required to best represent different types of stories. The unit includes news writing, critiquing published news stories, and feature and editorial writing. Students will also discover in-depth reporting, investigative reporting and how to write for publication.

## **Enduring Understanding**

- 1. Journalism courses encourage clarity of imagery (through vivid descriptive writing and reading), and accuracy of mood (through well-chosen, personality-revealing direct quotations from sources).
- 2. Recognizing mood and tone of sources is essential to accurate reporting, and personal opinion writing provides opportunities to explore tone in student writing.
- 3. Journalism provides an avenue for students to actually make use of figurative language, syntax, diction

and tone that they have studied in literature courses.

### **Essential Questions**

- What are the various types of articles and stories a journalist can create?
- How does an understanding of specific journalistic formats impact a writer's ability to communicate effectively?
- What is a feature? Investigative reporting? Editorial? Column?
- What are the purposes of different forms of journalism?
- Why do journalists choose specific forms of journalism depending on their audience and topic?

### **Exit Skills**

- Conduct, analyze, and incorporate appropriate mediums into all writing.
- Identify and apply journalistic techniques to writing process.
- Construct a news article, feature, opinion-editorial or interview.


