#### **Unit Overview**

The unit will address:

- The use of tone and mood;
- The use of foreshadowing for heightening suspense;
- The creation of interest with the use imagery, suggestive titles of each chapter and "cliff hangers;
- The connection between primitive man's "fight or flight" response and our present day response to danger;
- Terror and horror being intricately connected, and the literature that reflects that connection;
- The necessity for "suspension of disbelief;"
- The classic authors of horror writing;
- A world that has become desensitized to horror literature.

#### **Enduring Understanding**

- Literature reflects the cultural challenges and societal dilemmas of man, during the historical era in which it is set.
- Man loses his humanity and alienates those around him when he places work and the pursuit of money as the primary reasons for his existence.
- Fear is an integral component of the human psyche.

#### **Essential Questions**

- What are the characteristics of classic horror piece?
- Why do some authors become "classic" authors?
- What are the elements of good characterization?
- How does characterization support the plot?
- How does character conflict differ in the supernatural literature?
- Why is "suspension of disbelief" paramount to the enjoyment of supernatural fiction?

#### **Exit Skills**

- The student will be able to demonstrate an understanding of Charles Dickens's life by summarizing an article read about the author.
- The student will be able to describe Scrooge's character and support descriptions with evidence from the text,
- The student will be able to demonstrate understanding of how other characters feel towards Scrooge by citing evidence of good or bad comments that characters say about him.
- The student will demonstrate an understanding of the final spirits visit to Scrooge by citing textual evidence.
- The student will be able to compare and contrast the changed Scrooge to the new Scrooge with graphic organizers, using the novel as reference.
- The student will be able to write a five paragraph argumentative paper on which spirit they think caused Scrooge to change the most citing quotations from the text as proof.



# **Suggested Activities & Best Practices**

- Students will choose a scene from the novel "A Chritmas Carol" and deliver a dramatic monologue in which they envision how the character(s) would react to what is going on in the novel as other characters as well. This will help students to understand the novel and characterization of their chosen character's monologue.
- Regardless of one's religion, it is almost impossible to grow up in America today without being exposed to Christmas carols. Grocery stores and malls start playing them in late October and go on through December; you might also hear them on television shows and commercials or in films. In small groups, write new lyrics to the tunes of old carols. Each group will perform its "new carol" for the class. Your carols must deal specifically with an incident from the text of A Christmas Carol (or with the book as a whole). In addition, your carols must have at least three verses and a chorus (or

repeated refrain) that you return to between verses.
