Unit Overview

The most powerful and poignant stories are often the ones that are true. This unit exposes students to two of the most acclaimed biographical works in the graphic novel genre. In *Persepolis: The Story of a Childhood*, Marjane Satrapi recounts her tumultuous coming-of-age during the 1979 Iranian Revolution. As a memoir, *Persepolis* sheds light on an overlooked yet incredibly relevant piece of late 20th century history, introducing students to a cultural revolution whose effects are still felt today. The true stories contained in *Maus: A Survivor's Tale* are more narratively complex, managing to straddle the line between biography and memoir. Art Spiegelman skillfully presents readers with a stylized retelling of his father's experiences during World War II while also using the interview process as a window into his strained relationship with his father.

Essential Questions

1. How does the past shape the future?
2. How do extreme beliefs come about, and how can one stand against them?
3. Where do people learn their preconceived notions?
4. When is it acceptable to lie?

2. Make personal connections with characters and their conflicts
3. Write and illustrate a mini-memoir that focuses on an important event/experience

6. Evaluate the Satrapis' means of resisting/escaping the constraints of the fundamentalist regime
7. Interview family members and share their stories in a style similar to *Maus* (also including the interviews themselves)

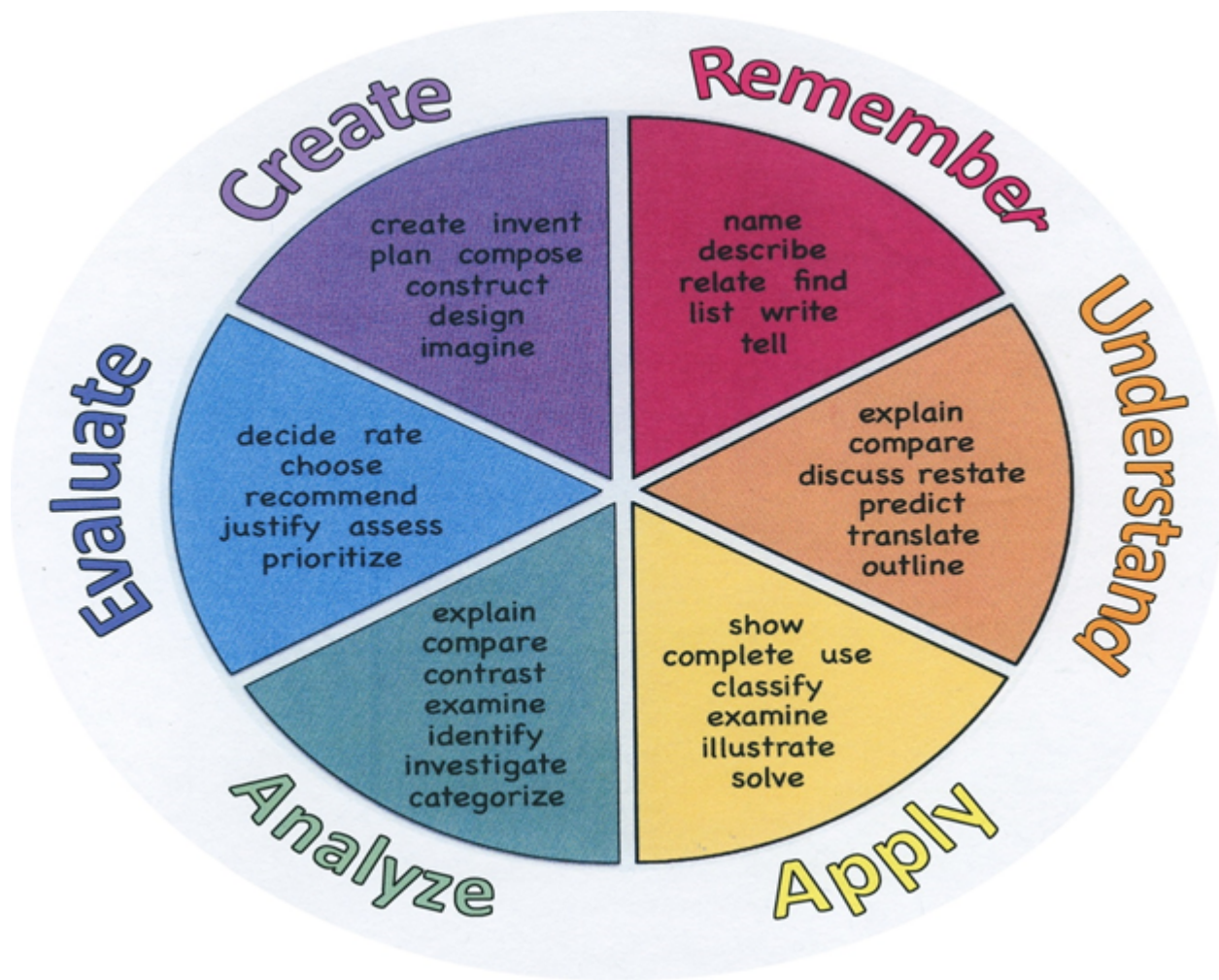

Suggested Activities & Best Practices

Students will complete regular journal prompts for assigned readings and write breakdowns and translations for specific scenes, in which they will analyze select scenes by deconstructing them down to their individual shots/transitions and write narrative translations of the silent sequences of images, complete with character's thoughts and dialogue. This will enhance their critical thinking skills, writing, and creativity.

Students will be required to read at least one supplemental text per marking period. They may choose from a recommended list or submit a book for approval. Students will be required to complete a reading log and a book review for each choice book. Every student will sign up to present at least one book review to the class before the end of the year. This will encourage students to read outside the classroom and in turn hopefully boost reading skills.
