## **Unit Overview**

---

## **Enduring Understanding**

---

- Music is a non-linguistic communication system
- Music theory systems are dynamic and changing
- Music theory is rooted in Ancient Greek and Roman ideals of beauty
- Combination and manipulation of musical elements makes a piece of music more or less successful. Knowing theory doesn't guarantee a "good" piece of music.
- Critique is an essential process to music making

- The elements of music contribute to music’s aesthetic and expressive nature
- Music is its own language with its own set of structure and syntax

- What purpose does a system serve?
- What makes a piece of music successful or unsuccessful?
- What can be learned from analyzing and evaluating the music of others? Myself?
- How does the study of music from different historical periods and cultures enrich my understanding of music today?

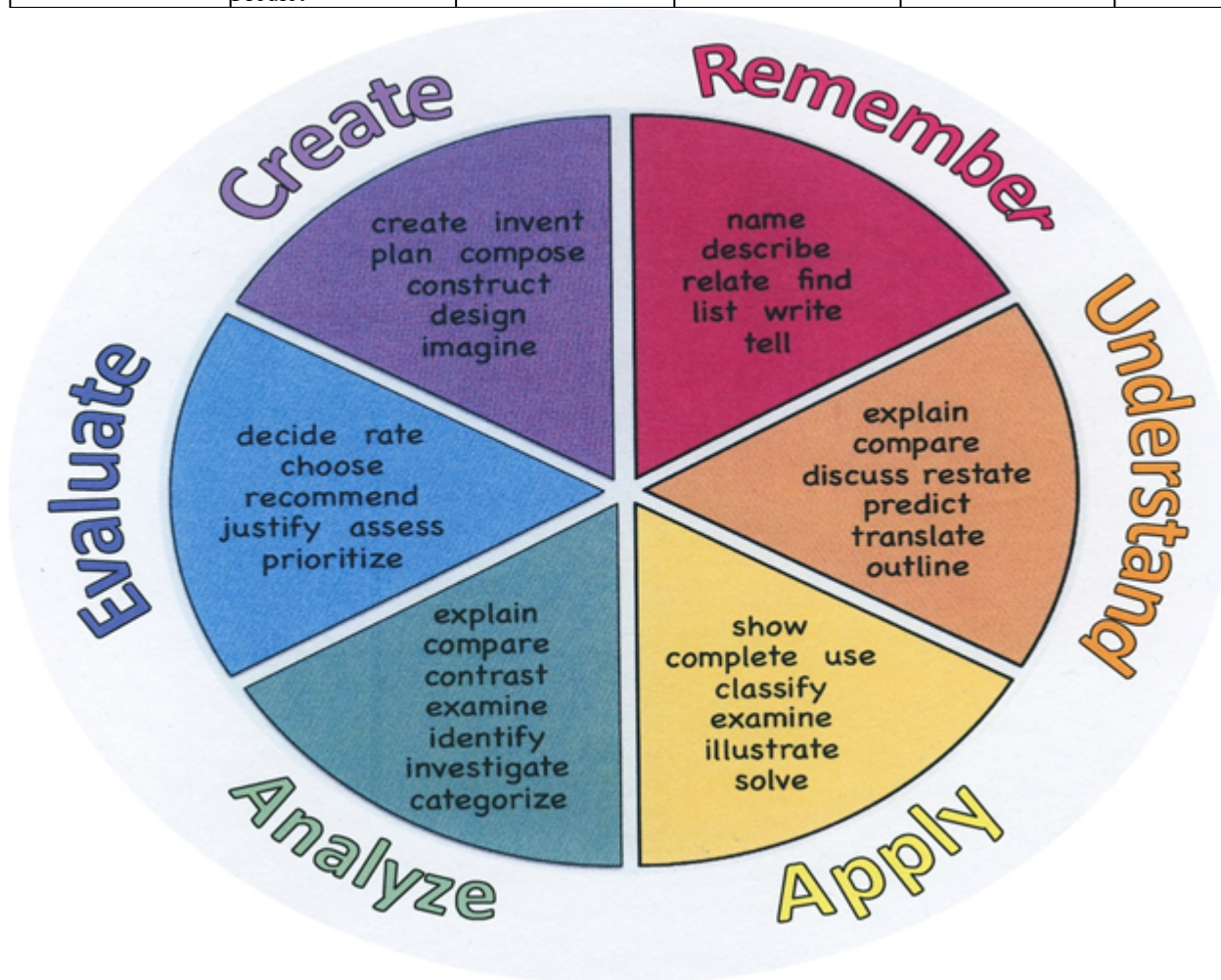
