#### **Unit Overview**

In this unit the students will learn how to identify and utilize secondary key changes in a peice of music.

## **Enduring Understanding**

- Music is a non-linguistic communication system
- Music theory systems are dynamic and changing
- Music theory is rooted in Ancient Greek and Roman ideals of beauty
- Combination and manipulation of musical elements makes a piece of music more or less successful. Knowing theory doesn't guarantee a "good" piece of music.
- Critique is an essential process to music making


