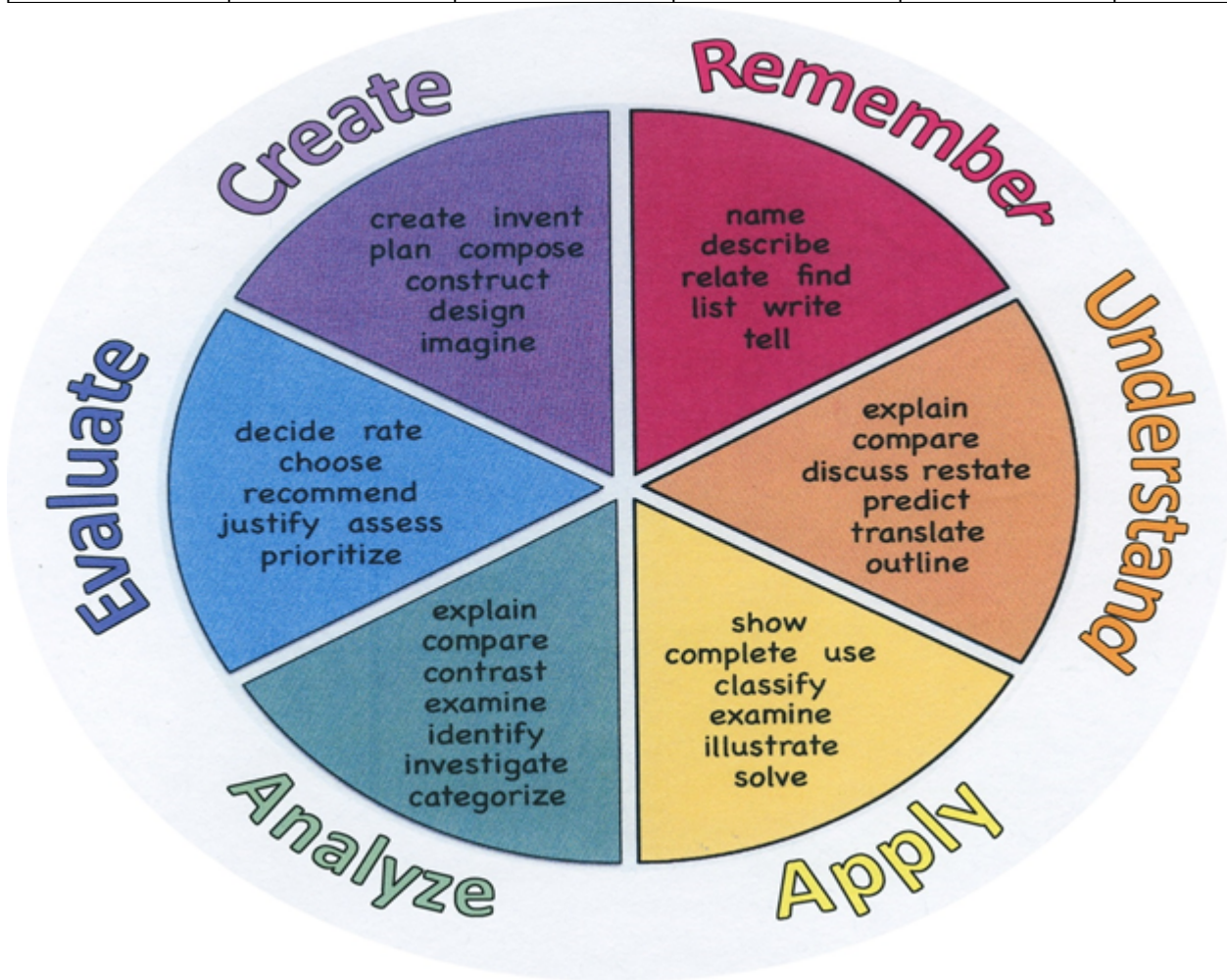

- View and respond to a variety of live/video performances representing a range of styles (classical, Western, contemporary) and venues (Broadway, off-Broadway, college, high school)
- Write reviews or comparative essay of two viewed performances contrasting performance elements, including - Theatre performance space - Scenery, costumes, lighting - Timing and pacing
- Research professional reviews of theatrical productions using computer resources. Create and develop justified textual and non-textual moments in a scene using sound and light, based on script analysis, dramaturgical study and director's vision
- Write or devise a short original play that conforms to the dramatic structure of one theatrical genre with a clear beginning, middle, and end.
- Direct a scene from a published or original work demonstrating suitable script analysis and clear visual aesthetics.
