Unit Overview

Students will examine case studies to evaluate common procedures used in forensic science where students look at evidence collection, preservation, and documentation. Students will also be introduced to new technologies in forensic science along with how forensic scientists use best practices and peer reviewed journal articles to improve best practices. Students will also be introduced to Ballistics and Tool Markings.

Enduring Understanding

- Evidence is needed to determine the method by which a crime has been committed.
- Evidence recovered from crime scenes has to be analyzed to determine the significance of that analysis to the crime.
- Trace Evidence can be recovered from crime scenes, processed and analyzed to determine criminal activities, investigators use specific scientific procedures and best practices to collect trace evidence.
- All forms of evidence must be properly preserved in order to recreate a complete picture of what took place before after and during a crime.
- Ballistics is the study of bullets and firearms, by recovering bullets and casings at a crime scene they can learn information

about the crime committed.

Essential Questions

- 1. What characteristics lead evidence to be considered in a case?
- 2. How is evidence used in a court during criminal procedures?
- 3. How are all types of trace and physical evidence processed and used during criminal trials?
- 4. What is meant by chain of custody?
- 5. How can be evidence be linked to suspects and scenes?
- 6. What are the procedures for approaching a crime scene, collecting and processing evidence, and what kinds of professionals and techniques are needed to process each type of evidence?

Exit Skills

- Distinguish between four manners of death: natural, accidental, suicidal, and homicidal.
- Distinguish between cause, manner, and mechanisms of death.
- Explain how the development of rigor, algor, and livor mortis occurs following death.
- Use evidence of rigor, algor, and livor mortis to calculate the approximate time of death.
- Describe the stages of decomposition of a corpse.
- Use evidence from the autopsy's report on stomach contents to estimate time of death.
- Explain how time of death can be estimated using insect evidence.
- Provide an example of the succession of different types of insects that are found on a body as it decomposes.
- Given insect evidence, livor, rigor, and algor mortis data, be able to estimate the time of death.
- Describe how various environmental factors may influence the estimated time of death.
