Unit Overview

In this unit, students will be introduced to the field of social psychology, including how our attitudes affect the way we see the world and the people in it, and the various factors that promote and inhibit attraction, conformity, obedience, aggression, and altruism. These social concepts will also be explored through discussions on the Holocaust, while reading *The Wave* by Todd Strasser.

Students will learn the following:

- The ways that people think and act in certain situations
- Attitudes, persuasion, attraction, and love as social issues
- The impact group interaction has on the behaviors and attitudes of individuals in every day life as well as in obscure social situations such as cults and extreme belifs
- An individual's tendency toward conformity, obedience, aggression, and altruism
- Bias and prejudice as social issues

Enduring Understanding

- Many factors influence social cognition, or how people think and act in situations.
- Social norms, conformity, obedience, aggression, and altruism all affect how people interact socially.

Essential Questions

- What are attitudes?
- How do attitudes develop?
- How does persuasion affect people's attitudes and behavior?
- What causes prejudice?
- How can prejudice be overcome?
- What factors influence our perceptions of other people?
- What role does attraction play in friendships and love relationships?
- How can membership in a group and social norms influence individual behavior?
- What factors lead people to conform to social norms and obey authority figures?
- What are the views on aggression and the factors that lead to altruistic behavior?
- How do social concepts such as attitudes, norms, attraction, conformity, obedience, aggression, and altruism relate to the novel *The wave* by Todd Strasser.

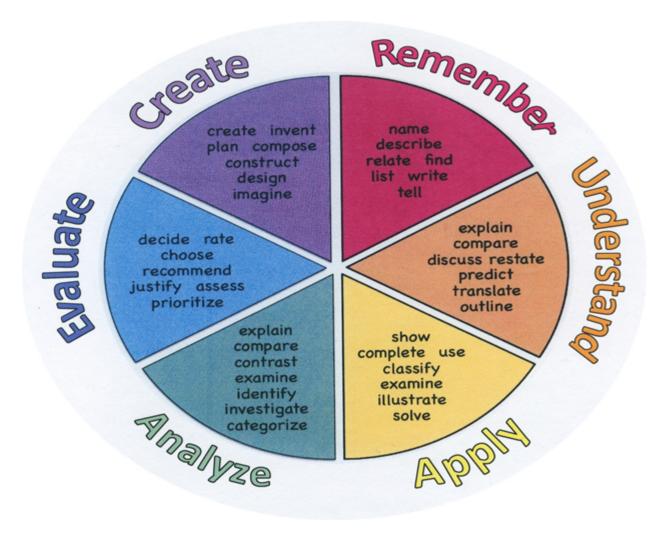

Suggested Activities & Best Practices

- Read case studies and psychological experiments related to Unit 4 (For example: "Acts of Altruism") and respond to related writing tasks using a personal response journal.
- Conduct experiments related to Unit 4 (For example: "Nonverbal Communication" Quick Lab; "Revisiting Milgrim" Experiment) and analyze the results using a rubric (student or teacher created).
- Analyze cartoons based on human behavior/psychology topics discussed in Unit 4 using a personal response journal.
- Create cartoons or other illustrations based on human behavior/psychology topics discussed in Unit 4.
- Student or teacher created rubrics for each project.
