Unit Overview

This unit will present the various concert scales students need to be able to advance their playing ability as young musicians. These scales should correlate to the music being included in the concert repertoire.

- Does music have to be considered beautiful by everybody?
- How do artists make decisions about their music?
- How does the time period in which a piece was written impact the performance of the piece?
- How does the piece's country of origin impact the performance of a piece?

At Risk

Allowing students to correct errors: The students will be allowed to repeat portions of their performance in order to correct any melodic or harmonic errors they may have.

- allowing students to correct errors (looking for understanding)
- teaching key aspects of a topic. Eliminate nonessential information
- allowing products (projects, timelines, demonstrations, models, drawings, dioramas, poster boards, charts, graphs, slide shows, videos, etc.) to demonstrate student's learning
- allowing students to select from given choices
- allowing the use of note cards or open-book during testing
- collaborating (general education teacher and specialist) to modify vocabulary, omit or modify items to reflect objectives for the student, eliminate sections of the test, and determine how the grade will be determined prior to giving the test.
- decreasing the amount of work presented or required
- having peers take notes or providing a copy of the teacher's notes
- marking students' correct and acceptable work, not the mistakes
- modifying tests to reflect selected objectives
- providing study guides
- reducing the number of answer choices on a multiple choice test

- tutoring by peers
- using authentic assessments with real-life problem-solving
- using true/false, matching, or fill in the blank tests in lieu of essay tests
- using videos, illustrations, pictures, and drawings to explain or clarify

Talented and Gifted Learning (T&G)

Above grade level placement for qualified students: Student that are able to, will complete scale studies above their specific grade level. For example, a 10th grade vocalist may be asked to complete the same scale studies as the 11th or 12th grade students.
