Unit Overview

Throughout Unit 5: In this unit, students will examine various literary and informational texts about why people find it entertaining to be frightened. They will also examine the elements of an argument in order to craft a written essay and participate in an argumentative presentation during the different performance tasks. Ultimately during all of the reading, writing, speaking & listening tasks, students will consider what it takes to face our fears.

Reading

By reading and evaluating an argumentative essay, reading fiction, non-fiction, and poetry student will better understand the ways writers express ideas.

Writing and Research

By learning the elements of writing an argumentative essay and writing their own argumentative essay students will learn how to write for a number of reasons and will conduct research to clarify and explore ideas.

Language

By developing a deer understanding of the correct use of pronouns and the use of irony in their writing, students will practice adding meaning to either writing through irony.

Speaking and Listening

By building on one another's ideas, and communicating with one another student will learn how to incorporate audio, visuals, and text in presentations.

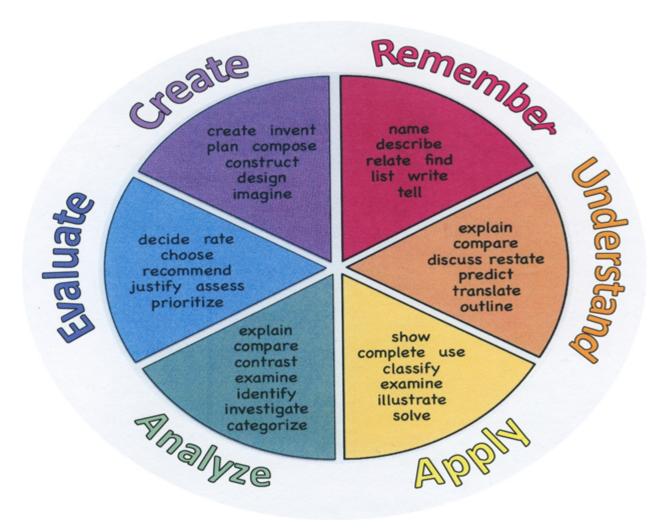
