Unit Overview

Students will focus on skills needed for the multiple choice and essay sections of the AP Language and Composition Exam from the workbooks purchased by the school in the fall.

Enduring Understanding

Good writers develop and refine their ideas for thinking, learning, communicating, and aesthetic expression.

Good writers use a repertoire of strategies that enables them to vary form and style, in order to write for different purposes, audiences, and contexts.

Rules, conventions of language, help readers understand what is being communicated.

A writer selects a form based on audience and purpose.

Understanding of a text's features, structures, and characteristics facilitate the reader's ability to make meaning of the text.

Readers use language structure and context clues to identify the intended meaning of the words and phrases as they are used in the text.

Researchers gather and critique information from different sources for specific purposes.

Essential Questions

- How do effective writers hook and hold their readers?
- How does a reader understand a writer's purpose?

At Risk

-Reduce multiple choice options and build the options back into the lessons so students get a feel for true AP questions

-Provide a copy of the teacher's notes on the class website

-Screencast a lesson/discussion.

- allowing students to correct errors (looking for understanding)
- teaching key aspects of a topic. Eliminate nonessential information
- allowing products (projects, timelines, demonstrations, models, drawings, dioramas, poster boards, charts, graphs, slide shows, videos, etc.) to demonstrate student's learning
- allowing students to select from given choices
- allowing the use of note cards or open-book during testing
- collaborating (general education teacher and specialist) to modify vocabulary, omit or modify items to reflect objectives for the student, eliminate sections of the test, and determine how the grade will be determined prior to giving the test.
- decreasing the amount of work presented or required
- having peers take notes or providing a copy of the teacher's notes
- marking students' correct and acceptable work, not the mistakes
- modifying tests to reflect selected objectives
- providing study guides
- reducing or omitting lengthy outside reading assignments
- reducing the number of answer choices on a multiple choice test

- using authentic assessments with real-life problem-solving
- using true/false, matching, or fill in the blank tests in lieu of essay tests
