Unit Overview

Unit 3 examines:

- The United States became more connected with the world, pursued an expansionist foreign policy in the Western Hemisphere and emerged as the destination for many migrants from other countries.
- Intensified by expansion and deepening, regional divisions, debates over slavery and other economic, cultural and political issues led the nation into civil war.
- The Union victory in the Civil War and the contested reconstruction of the South settled the issues of slavery and secession, but left unresolved many questions about the power of the federal government and citizenship rights.

- The South remained politically, culturally and ideologically different from other regions of the United States, despite certain economic ties between the South and the North.
- Free and enslaved African Americans developed a distinct society and created networks of support for each other.
- White southerners began to view slavery as a "positive good" rather than a 'necessary evil".
- White southerners developed a distinct social structure, emphasizing pride and honor.
- The South remained in a semi-colonial status to the North.
- There were significant differences in the labor systems of the North and South.
- Enslaved African Americans developed various means of resistance to the institution of slavery.
- The cotton economy and slavery shaped the political, economic and social development of the South.

Essential Questions

- Popular enthusiasm for US expansion, bolstered by economic and security interests, resulted in the acquisition of new territories, substantial migration westward, and new overseas initiatives.
- In the 1840s and 1850s, Americans continued to debate questions about rights and citizenship for various groups of US inhabitants.
- Ideological and economic differences over slavery produced an array of diverging responses from Americans in the North and the South.
- Debates over slavery came to dominate political discussion in the 1850s, culminating in the bitter election of the 1860 and the secession of Southern states.
- The North's greater manpower and industrial resources, the leadership of Abraham Lincoln and others, and the decision to emancipate slaves eventually led to the Union military victory over the Confederacy in the devastating Civil War.
- Reconstruction and the Civil War ended slavery, altered relationships between the states and the federal government, and led to debates over new definitions of citizenship, particularly regarding the rights of African Americans, women and other minorities.

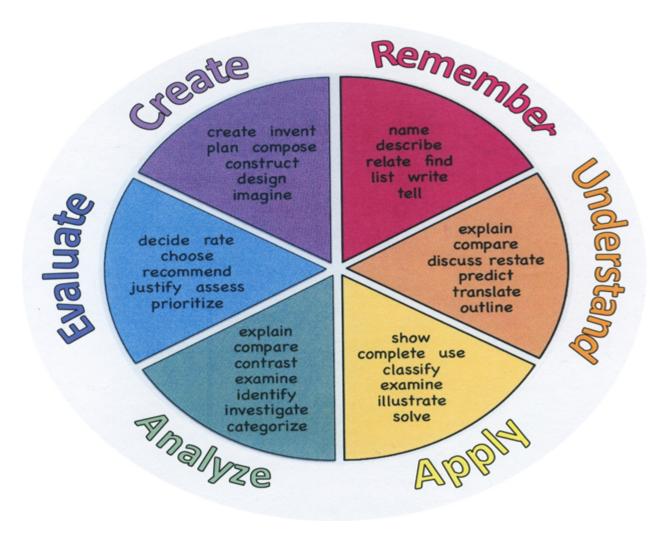
Learning Objectives

- Explain why Southerners came to defend slavery as a positive good rather than a necessary evil.
- Analyze the ways in which enslaved society and culture both resisted and accommodated the institution of slavery.
- Analyze the degree to which development of the factory system further isolated the South and set the stage for increased sectional tension.


