## **Unit Overview**

---

1. All substances are made of bonded elements, each with unique chemical and physical properties.
2. Substances consist of elements and compounds which chemically react to form new substances with properties that are different than their component substances.
3. Reactions result in property changes that can be examined to see the ways in which atoms from the original substances are combined and rearranged.
4. Chemical reactions can be classified to types.

## **Enduring Understanding**

---

- Ionic bonds form rigid structures with high melting points; covalent bonds form substances with lower melting points.
- Atoms bond to become stable by filling their valence shells by forming ionic or covalent bonds.
- A chemical reaction is the rearrangement of atoms by breaking and or forming bonds to create new

substances.

- Chemical equations are balanced in order to obey the Law of Conservation of Mass.
