#### **Unit Overview**

In this unit, students will be able to describe and explain the ways that motion is affected during collisions and other interactions with other systems. Students will apply the concepts of momentum and energy to motion problems in order to conceptualize and quantify inter-system interactions. Prior knowledge will be used to build new connections to mathematical relationships and interconnected quantities of motion, momentum, and energy.

#### **Enduring Understanding**

- An unbalanced force must be present to cause any change in an object's state of motion or rest.
- Inertia is the property of matter that resists change in motion.
- Gravitational force between two masses strengthens as the masses become more massive and rapidly weakens as the distance between them increases.
- When one object exerts an action force on a second object, the second object exerts a reaction force on the first object. Forces always occur in action-reaction pairs.
- Work is done when a force causes an object to move. This meaning is different from the everyday meaning of work.
- Power is the rate at which work is done.
- The mechanical advantage of a machine describes how much the machine multiplies force or increases distances.
- Energy is the ability to do work.
- Energy readily changes from one form to another.
- Students will relate to their Interactions with other objects or systems can change the total linear momentum of a system.
- The linear momentum of a system is conserved.
- The angular momentum of a system is conserved.



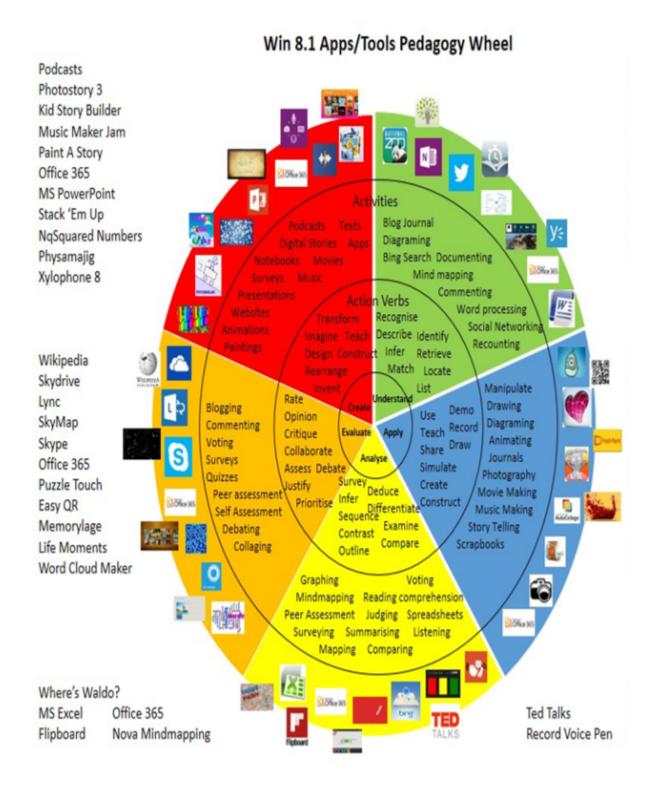
